ORDER: -

In the letter read above, the Registrar, Tamil Nadu Agricultural University has stated that the Agricultural College and Research Institute, Madurai is one of the constituent Colleges of Tamil Nadu Agricultural University and was started in the year 1965. In this college totally 550 Boys and Girls are studying. There are three Girls hostels and two Boys hostels with individual Kitchen and Dining. Therefore, it results in huge establishment for running and maintaining all the Kitchens and Dining Halls. Since the above Kitchens have conventional cooking facilities i.e Firewood, Stove, etc., it is very difficult to maintain the hygienic condition in the preparation of Food. Further, it is difficult to prepare food in the different Kitchens and to serve the food to students at same time. In order to overcome all these difficulties, it is proposed to provide one Integrated Modern Kitchen cum Dining and Students' Amenities Centre at the Agricultural College and Research Institute, Madurai. The Modern kitchen will be a centralized one with latest kitchen equipments and dining facilities for students. The Registrar, Tamil Nadu Agricultural University has sent the detailed estimates for this item of expenditure for a sum of Rs.250 lakh. The Board of Management of Tamil Nadu Agricultural University in its 166th Meeting held on 12.11.2013 has approved this item of work to be undertaken by Tamil Nadu Agricultural University with the Special Grant of State Government.

2. The Registrar, Tamil Nadu Agricultural University has, therefore, requested the Government to sanction, a special grant of Rs.250 lakh for the Construction of Integrated Modern kitchen cum Dining and Students' Amenities Centre in commemoration of the Golden Jubilee celebrations of that College.

3. The Government, after careful examination accept the proposal of the Registrar, Tamil Nadu Agricultural University and accordingly sanction a special Grant of Rs.2,50,00,000/- (Rupees Two Crore and fifty lakh only) for the construction of a Modern Kitchen cum Dining Hall and Students Amenities Centre at the Agricultural College and Research Institute, Madurai in commemoration of its Golden Jubilee Celebrations.

4. The amount sanctioned in para-3 above shall be debited to the following head of account:-

2415 – Agricultural Research and Education -01- Crop Husbandry – 120- Assistance to other Institutions – Schemes in the 12th Five year plan – II State Plan - JA – Grants to Tamil Nadu Agricultural University 09. Grants-in-Aid.-02. Grants for Creation of Capital Assets.

5. The expenditure sanctioned in para 3 above shall constitute an item of “New Instrument of Service” and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2015-16. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the contingency Fund. The Director of Agriculture is directed to calculate the actual amount required in consultation with Tamil Nadu Agricultural University for the period upto next supplementary Estimates and apply for sanction of the same as advance from the contingency Fund to Finance (BG-I) Department directly in Form “A” appended to the contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Director of Agriculture shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2015-16 without fail.

6. The Registrar, Tamil Nadu Agricultural University is directed to follow the existing Financial Procedures/ Government Orders while incurring the expenditure sanctioned in para 3 above. He is also directed to inform the progress of the work and expenditure made every month to Government.

7. This order issues with the concurrence of Finance Department vide its U.O.No.46033/Finance (Agriculture)/2015 dated 25.08.2015 with Additional Sanction Ledger No. 807 (Eight Hundred and Seven)
