ORDER:

The Hon'ble Minister for Agriculture, among others, has announced on the floor of the Assembly on 19.08.2016 that the implementation of the schemes through Agricultural Engineering Department involves large number of field visits for project preparation, preparation of plan and estimates and supervision during execution. As there is inconvenience of field visit by old vehicle in the Agricultural Engineering Department, Rs.5.53 crores will be allocated during 2016-17 for purchase of 85 motor vehicles on replacement of 85 old vehicles to Agricultural Engineering Department.

2. Based on the announcement, in his letter first read above, the Chief Engineer (Agricultural Engineering), has stated that the Agricultural Engineering Department has 11 Regions headed by Superintending Engineers, 36 Divisions Headed by Executive Engineers and 105 Sub Divisions headed by Assistant Executive Engineers in charge of implementation of Projects and programmes. There are 2 Chief Engineers, 3 Superintending Engineers and 3 Executive Engineers in the Head Quarters at Chennai.

3. The Chief Engineer (Agricultural Engineering) has also stated that the implementation of the schemes involves many number of field visits for project preparation, meeting the village community, Preparation of plan and estimates, supervision during execution and verification of individual farmers, post implementation of disbursal of subsidy etc. At present, the department has 136 jeeps and 12 cars. Out of these, 100 vehicles were purchased in the period from 1972 to 2006. Normally, vehicles which are grounded when they become unserviceable and are not used on road and they are being condemned by Motor Vehicle Maintenance Department. But the above mentioned department vehicles, even though they had served beyond their life time, are being used as there is no alternative and the annual ceiling of Rs.12,000/- fixed for the repairs is inadequate and have become uneconomical in fuel consumption. The Chief Engineer (Agricultural Engineering) has further informed that a total of 85 life old crossed vehicles are condemned, among them 77 vehicles are condemned on attaining the maturity by Motor Vehicle Maintenance Department and 8 vehicles are condemned on premature condition, vide Government Order second read above.

4. The Chief Engineer (Agricultural Engineering) has, therefore, requested the Government to accord sanction for the purchase of 85 Motor Vehicles at a cost of Rs.5.53 crores in replacement of 85 life crossed vehicles, which are condemned.

5. After careful examination, the Government have accepted the proposal of the Chief Engineer (Agricultural Engineering) and sanction an amount of Rs.5.53 crore (Rupees Five crores and Fifty three lakhs only) for the purchase of 85 New Motor Vehicles [Mahindra Jeeps BOLERO LX 2WD 7STR NAC BS3 PS (Non A/c)] at the rate of Rs.6.50 lakhs each to Agricultural Engineering Department in replacement of 85 life crossed vehicles which are already condemned, as per existing Director General of Supplies and Disposal's Rate (DGS&D), terms and conditions. The Chief Engineer (Agricultural Engineering) is permitted to purchase the above vehicles by following the usual procedure and to allot the above vehicle to the offices of Agricultural Engineering Department. The vehicles which were condemned, are indicated in the annexure to this order.

6. The amount sanctioned in the para-5 above shall be debited to the following head of account:-

"2401-00-Crop Husbandry -001- Direction and Administration I-Non Plan - AH - Agricultural Engineering Department - District Staff - 21 Motor Vehicles -01 Purchase".

7. The Chief Engineer (Agricultural Engineering) is authorized to draw and disburse the amount, sanctioned in para-5 above.

8. The expenditure sanctioned at para-5, shall not constitute an item of new service. However, it shall be brought to the notice of the legislature by the specific inclusion in the supplementary Estimates 2016-2017. The Chief Engineer (Agricultural Engineering) is directed to send proposal for including the expenditure in Final Modified Appropriation 2016-17 along with explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2016-17 to Finance (BG-1/Agri) Department at an appropriate time without fail.

9. This order issues with the concurrence of Finance Department vide its U.O.No.4392/Finance (Agri)/2017, dated 30.01.2017 and Additional Sanction Ledger No.1981 (One thousand nine hundred and eighty one only)


