- 3. The Government after careful examination, accept the proposals of Commissioner of Fisheries and accord approval for the following detailed project proposals and sanction a sum Rs.720.00 lakh (Rupees Seven crore and twenty lakh only) (Rs.360.00 lakh GOI share: Rs. 360.00 lakh State share) for the above purpose to the implementing Agency i.e. Commissioner of Fisheries under National Agriculture Development programme / Rashtriya Krishi Vikas Yojana 2015-16 subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted. The funding pattern of the scheme is 50:50.

- 4. The funds available under existing Centrally Sponsored / Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above projects. The projects should follow centrally prescribed cost norms and approved pattern of assistance. The Commissioner of Fisheries should take due care to ensure that there is no duplication of subsidy.
- 5. The Commissioner of Fisheries should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the schemes.
- 6. The expenditure sanctioned in para 3 above shall be debited to the Head of Account and component wise details of the projects as mentioned in the Annexure to this order.
- 7. Necessary additional funds will be provided in Revised Estimate / Final Modified Appropriation 2015-16. Pending provision of such funds in Revised Estimate / Final Modified Appropriation 2015-16, the Commissioner of Fisheries is authorized to draw and disburse the amount sanctioned in para 3 above. However, this expenditure shall be brought to the notice of Legislature by specific inclusion in the Supplementary Estimate 2015-16. She is also requested to include this item of expenditure sanctioned above, while sending proposals for Revised Estimate / Final

Modified Appropriation 2015-16 and also to send necessary explanatory note for including be above expenditure in the Supplementary Estimates 2015-16 to Government in Finance (AH, D&F / BG-I) Department without fail.

- 8. The Commissioner of Fisheries is authorized to draw the amount sanctioned in para 3 above and deposit it in the P.D. account of the Commissioner of Fisheries.
- 9. The Commissioner of Fisheries shall observe the comments / suggestions of State Level Sanctioning Committee while implementing the respective projects.
- 10. The Commissioner of Fisheries is directed to follow the respective operational guidelines while implementing the schemes.
- 11. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the Head of Departments' to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.
- 12. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the prescribed format by 10th of the subsequent month under intimation to this Government without fail.
