### ORDER:

During the 13<sup>th</sup> State Level Sanctioning Committee meeting of National Agriculture Development Programme held on 05.06.2015 under the Chairmanship of Chief Secretary to Government to sanction the project proposals for the year 2015-16, the following proposal of Department of Milk Production and Dairy Development was approved with observation that the proposal is to be taken for implementation during 2015-16 by providing Rs.300.00 lakh from the 1% administrative cost eligible under RKVY:-

2. Accordingly, the Managing Director, Tamil Nadu Cooperative Milk Producers Federation Ltd., has submitted the proposal to Government for issue of orders.

3. The Government after careful examination, accept the proposal of Managing Director, Tamil Nadu Cooperative Milk Producers Federation Ltd., and accord approval for the project "Doorstep veterinary and emergency health services - 155 units" and also accord permission to draw a sum of Rs.300.00 lakh (Rupees Three Crore only) for the above purpose from the 1% administrative fund available with Tamil Nadu Watershed Development Agency to the implementing Agency i.e. Department of Milk Production and Dairy Development / Tamil Nadu Cooperative Milk Producers Federation Ltd., under National Agriculture Development programme/

Rashtriya Krishi Vikas Yojana 2015-16, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted. Though, the funding pattern under National Agriculture Development Programme is 50:50 sharing basis between the Central and State Governments, as the project cost is met from the 1% administrative cost, sanction under State funds does not arise.

4. The funds available under existing Centrally Sponsored / Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above projects. The project should follow centrally prescribed cost norms and approved pattern of assistance. The Department of Milk Production and Dairy Development / Tamil Nadu Cooperative Milk Producers Federation Ltd., should take due care to ensure that there is no duplication of subsidy.

5. The Managing Director, Tamil Nadu Cooperative Milk Producers Federation Ltd., should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the scheme.

6. The Executive Director, Tamil Nadu Watershed Development Agency is authorized to disburse the amount permitted to be drawn as ordered in para 3 above to the Managing Director, Tamil Nadu Cooperative Milk Producers Federation Ltd., thro ECS / crossed cheque / RTGs from the 1% administrative fund available with Tamil Nadu Watershed Development Agency towards implementation of the scheme.

7. The Managing Director, Tamil Nadu Cooperative Milk Producers Federation Ltd., shall observe the comments / suggestions of State Level Sanctioning Committee while implementing the respective project.

8. The Managing Director, Tamil Nadu Cooperative Milk Producers Federation Ltd., is directed to follow the respective guidelines while implementing the scheme.

9. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the Head of Departments' to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing department.

10. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the prescribed format by 10<sup>th</sup> of the subsequent month under intimation to this Government without fail.
