## **ORDER:**

In the letter read above, the Director of Agriculture has stated that the Department of Agriculture is producing and distributing carrier based bio-fertilizers (3000 M.T) and Liquid based bio-fertilizers (6 Lakh Litres) through its State owned 22 bio-fertilizer production units, promoting the usage of eco-friendly, low cost and renewable input of Bio-fertilizers. Considering the impact of these Bio-fertilizers among the farmers of the State in achieving the desired results such as quality output, eco-friendly environment, toxic free agricultural produce through low cost, it is proposed to popularize and promote the use of Bio-fertilizers by renaming it as "Amma Bio-Fertilizers" to increase its awareness and usage among the farmers.
