### ORDER:

In the Government Order 1st read above, orders were issued based on the announcement made by the Hon'ble Minister for Agriculture and Farmers Welfare in the Agriculture Budget 2021-2022 and based on the proposal of the Director of Agricultural Marketing and Agri Business the confirmation notification was issued for Uniform Notification of the 40 commodities declaring the regulation of purchase and sale of the said agricultural produces in the notified market areas of 284 Regulated Markets Under 27 Market Committees in Tamil Nadu under clause (d) of sub-section (1) of section 9 of the Tamil Nadu Agricultural Produce Marketing (Regulation) Act, 1987 (Tamil Nadu Act 27 of 1989).

2. In the Tamil Nadu Gazette No 2<sup>nd</sup> read above, in exercise of the powers conferred by clause (d) of sub-section (1) of section 9 of the Tamil Nadu Agricultural Produce Marketing (Regulation) Act, 1987 (Tamil Nadu Act 27 of 1989), the Governor of Tamil Nadu confirms the regulation of marketing of the 40 Agricultural Produces in the notified market areas of 284 regulated markets under 27 market committee in Tamil Nadu.

3. In the letter 3<sup>rd</sup> read above, the Director of Agricultural Marketing and Agri Business has stated that, so many traders have requested to, reconsider the Government order issued in which Uniform Notification for the regulation of marketing of 40 Agricultural produces in the notified market areas of 284 regulated markets under 27 Market Committees in Tamil Nadu. Further the impact of above uniform notification, the market fee levied for the Agriculture produces including which are all not produced in the respective market areas also. Hence, the food processing industries and merchants are severely affected and that causes price hike for the consumers.

4. The Director of Agriculture Marketing and Agri Business has requested the Government to cancel / withdraw G.O.(Ms)No.84, Agriculture and Farmers Welfare [AM2(1)] Department, dated 23.04.2022 in which the notification was issued for the 40 Agricultural produces declaring the regulation of purchase and sale in the notified market areas of 284 Regulated Markets Under 27 Market Committees in Tamil Nadu under clause (d) of sub-section (1) of section 9 of the Tamil Nadu Agricultural Produce Marketing (Regulation) Act, 1987 (Tamil Nadu Act 27 of 1989).

5. The Government after careful examination, have decided to accept the proposal of the Director of Agriculture Marketing and Agri Business Accordingly, the Government direct that the notification issued in G.O.(Ms) No.84, Agriculture and Farmers Welfare (AM2) Department, dated: 23.04.2022 in which the confirmation notification was issued for Uniform Notification of the 40 commodities declaring the regulation of purchase and sale of the said agricultural produces in the notified market areas of 284 Regulated Markets Under 27 Market Committees in Tamil Nadu under clause (d) of sub-section (1) of section 9 of the Tamil Nadu Agricultural Produce Marketing (Regulation) Act, 1987 (Tamil Nadu Act 27 of 1989) be cancelled.

6. The Government also direct that the notification appended to this order shall be published in the Tamil Nadu Government Gazette.

7. The Works Manager, Government Central Press, Chennai-600 001 is requested to send twenty copies of the Notification as published in Tamil Nadu Government Gazette to the Agricultural Production Commissioner and Secretary to Government, Agriculture and Farmers Welfare Department, Secretariat, Chennai-9 and to send the bill

of cost towards publication of Notification to the Director of Agricultural Marketing and Agri Business, Chennai-600 032 for settlement.
