## **ORDER**

In the Government Order first read above, sanction was accorded to implement the scheme on erecting of 270 bore wells for 60 Joint Liability Groups and 210 individual farmers and a model demo high density orchard for taking up replanting of perennial horticulture crops like cashew in the Districts of Cuddalore and Villupuram at an outlay of Rs.1146.71 lakh. A sum of Rs.50.00 lakh was released from out of the above sanctioned amount to execute the bore well works during 2012-2013. Subsequently vide Government order second read above the balance amount of Rs.1096.71 lakh was released.

2. In his letter third read above, the Director of Horticulture and Plantation Crops has sent the proposal to accord and sanction an amount of Rs.22,80,000/- (Twenty two lakhs and Eighty thousands only) towards Provision of Borewells to Joint Liability Groups in Villupuram district for taking up replanting of perennial horticulture crops during 2015-2016.

3. The Government after careful examination, accept the proposal of the Director of Horticulture and Plantation Crops and accordingly sanction a sum of Rs.22,80,000/- (Twenty two lakh and Eighty thousand only) for providing Borewells to Joint Liabilities Groups in Villupuram District during 2015-2016, for taking up replanting of perennial horticulture crops under Cyclone Thane Rehabilitation.

4. The amount sanctioned in para-3 above, shall be debited following head of account:-

"2401-00-Crop Husbandry-119 Horticulture and Vegetable Crops – Schemes in the Twelfth five year plan – II – State Plan – LE – Agriculture package for Rejuvenation of Horticulture Crops affected by Cyclone "Thane" – 09 – Grants – in-Aid-01 Grants for Expenditure" (DP Code 2401-00-119-LE-0912).

5. The expenditure sanctioned in para 3 above constitute an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the contingency fund. The Director of Horticulture & Plantation Crops is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency fund to Finance (BG-1) Department directly in Form-A appended to the Tamil Nadu Contingency Fund Rules-1963 along with a copy of this order. Orders for sanction of advance from the Contingency Fund will be issued from Finance (BG-1) Department. He is also requested to send necessary explanatory notes for inclusion of the above expenditure in the Revised Budget Estimates/ Supplementary Estimates 2016-17 to Finance (BG-1) Department at an appropriate time without fail.

6. The Director of Horticulture and Plantation Crops is permitted to draw and disburse the amount sanctioned in para-3 above, to the Deputy Director of Horticulture, Villupuram in the manner indicated in para 5 above. He is also directed to follow the existing Financial Procedures/Government Orders while incurring the Expenditure.

7. The Director of Horticulture and Plantation Crops is further directed to adhere the orders issued in para 3(i) to (vii) of the G.O. (Ms). No.44, Agriculture (H1) Department, dated 11.03.2013.

8. The Chief Engineer (Agricultural Engineering), the Chairman and Managing Director, Tamil Nadu Generation and Distribution Corporation Limited (TANGEDCO) and Tamil Nadu Electricity Board Limited and the Registrar of Co-operative Societies are requested to render necessary assistance for the speedy implementation of the scheme.
