ORDER:

During the 13th State Level Sanctioning Committee Meeting of National Agriculture Development Programme held on 05.06.2015 under the Chairmanship of Chief Secretary to Government to sanction the project proposals for the year 2015-16, the following proposals of Department of Milk Production and Dairy Development were approved with observations as mentioned in the minutes of the above meeting:-

2. Accordingly, the Commissioner for Milk Production and Dairy Development has submitted proposals to Government for issue of orders.

3. The Government after careful examination, accept the proposals of Commissioner for Milk Production and Dairy Development and accord administrative sanction for a sum Rs.1405.00 lakh (Rupees Fourteen Crore and Five lakh only) (Rs.702.50 lakh GOI share : Rs.702.50 lakh State share) and accord financial sanction for a sum of Rs.702.50 lakh (Rupees Seven crore two lakh and fifty thousand only) for the following detailed project proposals to the implementing Agency i.e. Department of Milk Production and Dairy Development / Tamil Nadu Cooperative Milk Producers Federation Ltd., under National Agriculture Development programme / Rashtriya Krishi Vikas Yojana 2015-16 subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted. The funding pattern of the scheme is 50:50 sharing basis by the Central and State Governments:-

4. The funds available under existing Centrally Sponsored / Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above projects. The projects should follow centrally prescribed cost norms and approved pattern of assistance. The Department of Milk Production and Dairy Development / Tamil Nadu Cooperative Milk Producers Federation Ltd., should take due care to ensure that there is no duplication of subsidy.

5. The Commissioner for Milk Production and Dairy Development should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the schemes.

6. The expenditure sanctioned in para 3 above shall be debited to the following Head of Account:-

7. Necessary additional funds of Rs.702.50 lakhs will be provided in Revised Estimate / Final Modified Appropriation 2015-16. Pending provision of such funds in Revised Estimate / Final Modified Appropriation 2015-16, the Commissioner for Milk Production and Dairy Development is authorized to draw and disburse the amount sanctioned in para 3 above. However, this expenditure shall be brought to the notice of Legislature by specific inclusion in the Supplementary Estimate 2015-16. He is also requested to include this item of expenditure while sending proposals for Revised Estimate / Final Modified Appropriation 2015-16 to Government in Finance (AHD&F/ BG-I) Department without fail.

8. The Commissioner for Milk Production and Dairy Development shall observe the comments / suggestions of State Level Sanctioning Committee while implementing the respective projects.

9. The Commissioner for Milk Production and Dairy Development is directed to follow the respective guidelines while implementing the schemes.

10. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the Head of Departments' to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.

11. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the prescribed format by 10th of the subsequent month under intimation to this Government without fail.
