### ORDER:

The Government of India have given administrative approval for Rs.72.75 crore to implement Micro Irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) for the year 2015-16.

2. In the letters first read above, the Government of India have released an amount of Rs.3601.1198 lakh as second instalment i.e Rs.2837.24 lakh for General Category and Rs.763.88 lakh for SCSP category for the implementation of PMKSY during 2015-16.

3. In Government Order second read above, a sum of Rs.6710.7179 lakh sanctioned and released (General Category Rs.5567.3259 lakh and SCSP category Rs. Rs.1143.3920 lakh) towards the smooth and successful implementation of Micro Irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana during 2015-16 in Tamil Nadu and it was also ordered therein that the balance amount will be provided in the next financial year 2016-17.

4. In his letter third read above, the Director of Horticulture and Plantation Crops/Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to sanction and release the balance amount of second installment of a sum of Rs.5403.2395 lakh which includes for General category a sum of Rs.3977.0042 lakh and for SCSP category a sum of Rs.1426.2353 lakh. He has also requested the Government to allocate the above amount under General and SC category additionally in addition to the proposed amount of Rs.31957.447 lakh in the 2016-17 Budget for smooth and successful implementation of Micro Irrigation Scheme.

5. The Government after careful examination, accept the proposal of Director of Horticulture and Plantation Crops/ Managing Director, Tamil Nadu Horticulture Development Agency and accordingly sanction and release a sum of Rs. 5403.2395 lakh (Rupees fifty four crores, three lakhs, twenty three thousand nine hundred and fifty only) which includes for General category a sum of Rs.3977.0042 lakh and for SCSP category a sum of Rs.1426.2353 lakh towards the smooth and successful implementation of Micro Irrigation scheme under PMKSY during 2016-17.
