#### **ORDER:**

The Government of India have given administrative approval for Rs.72.75 crore to implement Micro Irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) for the year 2015-16.

2) In the Government of India letter third read above, Government of India have revised the funding pattern of Micro Irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana between Central and state Government as 60:40.

- 3) In the letter fourth read above, Government of India have released an amount of Rs.36.38 Lakh as second instalment under TSP category for the implementation of Micro Irrigation Scheme under Mantri Krishi Sinchayee Yojana during 2015-16.
- 4) In the letter fifth read above, the Director of Horticulture & Plantation Crops/Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government, to sanction and release the Government of India share along with matching State share Rs.122.3802 lakh (Rupees One crore twenty two lakh Thirty eight thousand and twenty only) under TSP Category towards the smooth and successful implementation of Micro Irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana during 2015-16.
- 5) The Government after careful examination, accept the proposal of Director of Horticulture & Plantation Crops/Managing Director, Tamil Nadu Horticulture Development Agency and accord sanction for a sum of Rs.122.3802 lakh (Rupees One crore twenty two lakh Thirty eight thousand and twenty only)which includes the Government of India Share is Rs.36.38 lakh, Rs.23.0407 lakh matching State share and additional State subsidy of Rs.62.9595 lakh towards the smooth and successful implementation of Micro Irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana during 2015-16 in Tamil Nadu.
