ORDER:

In the Government Order first read above among others, orders have been issued sanctioning a sum of Rs.5465.00 lakh (Rs.2732.50 lakh under National Agriculture Development Programme and Rs.2732.50 lakh from State fund) for implementation of Kuruvai Package assistance in six districts of Cauvery Delta during 2016-2017 as detailed below:-

- (ii) to permit the Joint Directors of Agriculture, Tiruvarur and Nagapattinam Districts to surrender the savings of Rs.80,11,200/- [i.e. Rs.28,77,600/- for Tiruvarur District and Rs.51,33,600/- for Nagapattinam District] after the adjustment of excess amount.
- 5) The Government, after careful examination of the above proposal of the Director of Agriculture, permit the Joint Directors of Agriculture, Tiruvarur and Nagapattinam Districts to adjust the excess expenditure of Rs.27,88,800/- (Rupees Twenty Seven Lakh Eighty Eight Thousand and Eight Hundred only) (Rs.25,22,400/- for Tiruvarur District and Rs.2,66,400/- for Nagapattinam District) under "Encouraging Pulses cultivation in Cauvery basin and GAC sub basin" from the savings under the component "Distribution of Green Manure Seeds" in Vennar region, under the relevant heads of account as detailed in para 4 above on the condition that, the amount apportioned to the heads of account mentioned at para 4 of the Government Order first read above should not be exceeded. Further, the Joint Directors of Agriculture, Tiruvarur and Nagapattinam Districts are directed to surrender the savings of Rs.80,11,200/- (Rupees Eighty Lakh Eleven Thousand and Two Hundred only) [i.e. Rs.28,77,600/- for Tiruvarur District and Rs.51,33,600/- for Nagapattinam District] to Government immediately after the adjustment of excess amount.
