ORDER:

In the Government order first read above, orders were issued for implementing Price Support Scheme (PSS) for procurement of Copra at Minimum Support Price for Milling Copra as Rs.103.35 and Ball Copra as Rs.106.00 per Kg for 2021 Copra season.

- 2. The Government of India have fixed the Minimum Support Price for Milling Copra as Rs.10,590/- per quintal i.e Rs.105.90 per Kg and Ball Copra as Rs.11,000/- per quintal i.e Rs.110.00 per Kg for 2022 Copra season.
- 3. The Director of Agriculture in the letter third read above has reported that in Tamil Nadu, Coconut is cultivated in an extent of 4.39 take nectares with an annual production of 49,474 take nuts with the productivity of 11271 nuts per hectare. The coconut farmers prefer selling their produce in the form of Coconut, Tender Coconut and Copra. The market price of Milling Copra in major Copra Markets is now prevailing between Rs.110.00 to Rs.115.00 per Kg which is subjected to variation in the course of

year. There is a possibility that the price may go down in the later part of the year. In the event of fall in price of Copra, to ensure that the farmers are getting remunerative price for their Copra produced, Price Support Scheme has to be implemented. Therefore there is a need for implementation of Price Support Scheme (PSS) to help the coconut growers.

- 4. The Director of Agriculture has also stated the Procurement season may be fixed from January 2022 to June 2022.
- 5. The Director of Agriculture has stated that the Government of India has issued comprehensive Guidelines in May 2014 for effective implementation of Price Support Scheme (PSS) to ensure that the farmers are benefited for getting remunerative price. As a part of the Price Support Scheme, a notification has to be issued by the Agriculture Department of the State Government indicating the sown area, expected production, average yield, peak arrival / harvesting period of Copra and willingness to implement the Price Support Scheme. The Government of India has also informed that the National Agricultural Cooperative Marketing Federation of India Limited (NAFED) and National Cooperative Consumers Federation (NCCF) will be Central Nodal Agencies (CNAs) for procurement of Copra and Dehusked Coconut under Price Support Scheme.
- 6. In the Government orders second read above, orders have been issued appointing the Tamil Nadu State Agricultural Marketing Board as State Level Supporter, Marketing Committees as Primary Procurement Agencies (PPAs) and Regulated Markets as Primary Procurement Centres (PPCs) respectively for procuring Copra from the farmers under Price Support Scheme (PSS) from April to September 2021.
- 7. The Director of Agriculture has sent a detailed proposal to the Government for issue of Notification for the procurement of Copra in the State of Tamil Nadu under Price Support Scheme (PSS) for 2022 season.

Crop calendar and Harvesting period of Coconut in the State of Tamil Nadu A remunerative and stable price environment for Coconut growers/farmers is very important for increasing Coconut production and productivity. The market price for Copra many times tends to be unstable and volatile resulting in undue losses to the growers /farmers as well as discourages adoption of the modern technology and required inputs.

The Government's price policy for agricultural commodities seeks to ensure remunerative prices to the growers for their produce with a view to encourage higher investment and production and to safeguard the interest of consumers by making available supplies at reasonable prices with low cost of intermediation. The price policy also seeks to evolve a balanced and integrated price structure in the overall perspective of the needs of the economy.

Towards this end, the Government announces Minimum Support Price (MSP) for major agricultural commodities each year in both the Crop seasons after taking into account the recommendations of the Commission for Agricultural Costs and Prices (CACP).

In the scheme for the procurement of Copra in the year of 2022, as per the guidelines of Government of India (Department of Agriculture and Co-operation), the notification regarding Crop calendar and harvesting period of Coconut in Tamil Nadu is to be required as a part of the proposal.

Therefore, the Government of Tamil Nadu is willing to implement the Price Support Scheme (PSS) and its operation in Tamil Nadu and accordingly declare the following details:
