ORDER:-

In G.O.(Ms)No.345, Agriculture (OS) Department, dated 30.11.2001 the Government have directed the Commissioner of Agriculture / Registrar of Oilseeds Growers Co-operative Societies to take appropriate proceedings under section 137 of the Tamil Nadu Co-operative Societies Act, 1983 to wind up the activities of Tamil Nadu Co-operative Oilseeds Growers' Federation Limited. Accordingly, it was wounded up with effect from 31.03.2002.

- 2. In G.O.Ms) No.142, Agriculture (OS) Department, dated 4.6.2002 orders were issued to the effect that the Area Agronomic Centre and Training Centre at Neyveli, the Area Offices at Thiruvannamalai, Vridhachalam, Cheyyar, Madurai, Erode and Tirunelveli with the staff attached to these units were transferred to the control of the Commissioner of Agriculture, subject to maintaining a separate identity consequent to winding up of Tamil Nadu Co-operative Oilseeds Growers' Federation Limited.
- 3. It was also ordered in the above Government Order that the employees so absorbed shall be treated as Government servants from the date of issue of the above mentioned order i.e with effect from 4.6.2002. Subsequently, in G.O.(Ms) No.310, Agriculture (OS) Department, dated 23.11.2005, an amendment was issued to the effect that the Tamil Nadu Co-operative Oilseeds Growers' Federation Limited employees are eligible under regular pension scheme applicable to regular Government servants with effect from 1.4.2002.

- 4. The Commissioner of Agriculture in his proposal has requested the Government to include the period of service rendered in Tamil Nadu Co-operative Oilseeds Growers' Federation Limited for the purpose of calculation of Gratuity. The Commissioner of Agriculture has furnished various reasons in support of his proposal as detailed below:-
 - A. As ordered in the G.O. (Ms) No.142, Agriculture (OS) Department, dated: 4.6.2002, the following follow up actions were completed:
 - i) The employees thus absorbed from Tamil Nadu Co-operative Oilseeds Growers' Federation Limited were treated as Government servants with effect from 1.4.2002 and the pay of all concerned were protected.
 - ii) The leave earned by the employee in Tamil Nadu Co-operative Oilseeds Growers' Federation Limited were transferred to the Department of Agriculture.
 - iii) As per the G.O.(Ms) No.142, Agriculture (OS) Department dated 4.6.2002, SI.No. 5(x) the gratuity amount of the employees for the period of service rendered in Tamil Nadu Co-operative Oilseeds Growers' Federation Limited were credited into the Government Head of Account as detailed below:-

B. In W.A No.427 and 428 of 2005 and WA(MP) Nos.783 and 784 of 2005, two retired employees of Tamil Nadu Co-operative Oilseeds Growers' Federation Limited have filed case against the Tamil Nadu Co-operative Oilseeds Grower's Federation Limited for non settlement of gratuity for the period of services rendered by them in Tamil Nadu Co-operative Marketing Federation Limited (TANFED) (Incidentally, those two employees were absorbed from Tamil Nadu Co-operative Marketing Federation (TANFED) to Tamil Nadu Co-operative Oilseeds Grower's Federation Limited in 1985 vide Government Order dated 04.07.1985) The Hon'ble High Court, Chennai has passed orders that since those two employees had rendered continuous service for not less than 5 years, the present employer is liable to pay gratuity for the period of service rendered with previous employer (TANFED) as per Section 4 of Payment of Gratuity Act, 1972.

- 5. The Commissioner of Agriculture has further stated that the gratuity for the period of service rendered in Tamil Nadu Co-operative Oilseeds Grower's Federation Limited should be paid by the Department of Agriculture since there was no break in service rendered in Tamil Nadu Co-operative Oilseeds Grower's Federation Limited already remitted in Government Head of Account and as such the gratuity amount for the period of service rendered in Tamil Nadu Co-operative Oilseeds Grower's Federation Limited is now in the Government Account.
- 6. The Commissioner of Agriculture has also added that in view of the reasons and justifications furnished above and as such the gratuity amount was already remitted in Government Head of Account, it is appropriate that for the purpose of calculation of gratuity amount the period of service rendered with the previous employer (TANCOF) should also be taken into account for sanction of gratuity amount to the retired employees of Tamil Nadu Co-operative Oilseeds Grower's Federation Limited absorbed into the Department of Agriculture. The Commissioner of Agriculture has requested the Government to issue suitable instructions to the Accountant General to the effect to accept the sanction of gratuity by taking into account the period of service rendered in Tamil Nadu Co-operative Oilseeds Grower's Federation Limited.
- 7. The Government after careful consideration accept the proposal of the Commissioner of Agriculture and decided to refund the gratuity amount to the erstwhile employees of Tamil Nadu Co-operative Oilseeds Grower's Federation Limited as detailed below:-
