During the 12th State Level Sanctioning Committee meeting of National Agriculture Development Programme held on 14.11.2014 under the chairmanship of Chief Secretary to Government, the following project proposal of Dairy Development Department among others were approved under National Agriculture Development Programme for 2014-15:-

- 2. Accordingly, the Commissioner for Milk Production and Dairy Development has sent proposal for the above project under National Agriculture Development Programme (NADP) for the year 2014-15 for issue of orders.
- 3. In Government Order fourth read above, among other projects, administrative sanction has been accorded for implementation of the project indicated in para 1 above at the outlay of Rs.1072.74 lakhs inclusive of RIDF XX loan of Rs.983.06 lakh from National Bank for Agriculture and Rural Development (NABARD).
- 4. The Government after careful examination, accord revised administrative approval for implementation of the said project of Department of Dairy Development / Tamil Nadu Cooperative Milk Producers Federation Ltd., at the cost of Rs.1463.08 lakh and financial sanction for an amount of Rs.Rs.480.02 lakh (Rupees

Four crore Eighty lakh and Two thousand only) under National Agriculture Development programme / Rashtriya Krishi Vikas Yojana for 2014-15 for the above purpose. The balance amount of Rs.983.06 lakh shall be met out from loan sanctioned from NABARD, under RIDF XX loan as detailed below, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted:-

5. The sum of Rs.480.02 lakh sanctioned in para 4 above shall be debited to the following Head of Account:-

2404-00- Dairy Development -102 Dairy Development Project Schemes in the Twelfth Five Year Plan –II State Plan – JH National Agriculture Development Programme (NADP/RKVY) – Milk Production and Dairy Development Department – 09 Grants – in – Aid 03 – Grants for Specific Schemes. (DPC 2404 00 102 JH 0938).

- 6. Necessary additional funds of Rs.480.02 lakh will be provided in Revised Estimate / Final Modified Appropriation 2015-16 to meet the expenditure sanctioned in para 4 above. Pending provision of such funds in Revised Estimate / Final Modified Appropriation 2015-16, the Commissioner for Milk Production and Dairy Development is permitted to draw the amount of Rs.480.02 lakh sanctioned under National Agriculture Development Programme in para 4 above and disburse the same to the Managing Director, Tamil Nadu Cooperative Milk Producers Federation Ltd., This should be brought to the notice of legislature by specific inclusion in the Supplementary Estimates 2015-16. The Commissioner for Milk Production and Dairy Development is directed to include the expenditure sanctioned above while sending the Budget Proposals for Revised Estimate / Final Modified Appropriation 2015-16 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimates 2015-16 to Finance (AH,D&F/BG-I) Department without fail.
- 7. The funds available under existing Centrally Sponsored / Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above project. The project should follow centrally prescribed cost norms and approved pattern of assistance. The Department of Dairy Development should take due care to ensure that there is no duplication of subsidy.
- 8. The Commissioner for Milk Production and Dairy Development / Managing Director, Tamil Nadu Cooperative Milk Producers Federation Ltd., should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the scheme.

- 9. The Commissioner for Milk Production and Dairy Development / Managing Director, Tamil Nadu Cooperative Milk Producers Federation Ltd., should follow the operational guidelines of National Agriculture Development Programme while implementing the above scheme.
- 10. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the HOD's concerned to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.
- 11. The Executive Director, Tamil Nadu Watershed Development Agency to send the monthly progress report to Government of India, in the prescribed format by 10th of the subsequent month under intimation to this Government without fail.
- 12. This order issues with the concurrence of Finance Department vide its U.O.No.42503/AH,D&F/2015, dated:28.10.2015 and Additional Sanction Ledge No.1162 (One Thousand One Hundred and Sixty Two).
