ORDER:

In the Government Order first read above, orders were issued according administrative sanction for a sum of Rs.13.6065 crores for implementing the Watershed Development Fund (WDF) scheme to the Executive Director, Tamil Nadu Watershed Development Agency.

2) The Executive Director, Tamil Nadu Watershed Development Agency has now stated that no budgetary provision was made for the above sum of Rs.13.6065 Crores and also informed that Rs.13.6065 Crores is required for implementation and completion of 41 projects which are now under Full Implementation Phase stage under Tamil Nadu Watershed Development Agency fold and requested to release the above amount in two instalments (i.e) for 2016-2017 and 2017-2018.

- the Executive Director, 3) Now Tamil Nadu Watershed Development Agency in his letter 3rd read above, has requested the Government to sanction a sum of Rs.6.5407 Crores (Rupees Six crores fifty four lakhs and seven thousand only) for implementing 41 Projects under TAWDEVA fold for the year 2015-2016 under the Watershed Development Fund (WDF) Scheme in RE/FMA 2016-17 and the Commissioner of Agriculture may be authorized to draw and disburse the amount to Tamil Nadu Watershed Development Agency PD Account pending provision in Revised Estimate / Final Modified Appropriation 2016-17.
- 4) The Government, after careful consideration accept the proposal of the Executive Director, Tamil Nadu Watershed Development Agency, and accord sanction for a sum of Rs.6.5407 crores (Rupees Six crores fifty four lakhs and seven thousand only) towards the implementation and completion of 41 Projects which are now under Full Implementation Phase (FIP) stage under TAWDEVA fold for the year 2016-2017.
- 5) The expenditure sanctioned in para -4 above shall be debited to the following head of account:-

6). Necessary additional funds will be provided in Revised Estimate/Final Modified Appropriation 2016-2017 under the relevant head of accounts. However, this expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate 2016-2017. Pending provision of such funds, the Commissioner of Agriculture is authorized to draw and disburse the amount sanctioned in para 4 above. The Commissioner of Agriculture is also requested to

include this expenditure while sending the proposal for Revised Estimate/Final Modified Appropriation 2016-2017 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimates 2016-2017 to Government in Finance (Agri/BG-1) Department at the appropriate time without fail.

- 7) The Commissioner of Agriculture is authorized to draw the amount sanctioned in Para -4 above and deposit the same in the PD Account of Tamil Nadu Watershed Development Agency by following the procedure as prescribed in G.O (Rt) No.1251, Finance (WM-II) Department, dated 30.12.2005.
