ORDER:

In the letter third read above, the Managing Director, Tamil Nadu Agro Industries Development Corporation has stated that the Sunflower Oil Complex (SOC) Unit which is situated at Jambukuttapatti Village, Pochampalli, T.K., Krishnagiri District was closed as per the Government Order second read above, due to the low capacity utilization of the oil seeds extraction plant and continuous loss sustained and all the workers have been retrenched from the services on 10.03.2003. The unit was not functioning from the date of closure (i.e) with effect from 11.03.2003. The Plant and Machineries available in the units are kept idle for more than 14 years. The condition of the above said machineries became deteriorated. Hence it has been proposed to dispose off, the same. This subject was placed before the Board of Directors of Tamil Nadu Agro Industries Development Corporation Limited in it's 246th Board Meeting and the Board has decided to form an Expert Committee.

2. In the meantime, orders have been issued in G.O. fourth read above, to issue 'No Objection Certificate' to strike off the name of Tamil Nadu Agro Industries Development Corporation Limited, from the Register maintained by Registrar of Companies, and to transfer all assets and liabilities of Tamil Nadu Agro Industries Development Corporation Limited to Commissioner of Agricultural Marketing and Agri Business. Hence, the Managing Director, Tamil Nadu Agro Industries Development Corporation Limited has again reiterated his earlier proposal.

3. The Government have examined the proposal of Managing Director, Tamil Nadu Agro Industries Development Corporation Limited and decided to appoint the following valuer from Empanelled list of Valuers maintained by the Tamil Nadu Industrial Investment Corporation Limited (TIIC) who has the Expertise in valuing the old plant and machineries to assess the upset price (i.e. present market value) of the Plant and Machineries of Sunflower Oil Complex (SOC) Pochampalli, Krishnagiri, belongs to Tamil Nadu Agro Industries Development Corporation Limited:-

4. The terms and conditions of the valuers, as indicated in the reference sixth read above is adhered to, while fixing the upset price of plant and machineries of Sunflower Oil Complex, Pochampalli. The Government direct that the valuer shall submit his report to Managing Director, Tamil Nadu Agro Industries Development Corporation Limited / Commissioner of Agricultural Marketing and Agri Business within a period of 3 months from the date of taking over charges to take further action in the matter.
