ORDER:-

In the Government order first read above, orders have been issued according administrative approval and sanction for an amount of Rs.1370.00 lakh (GOI share Rs.822.00 lakh and State share Rs.548.00 lakh) for the implementation of the Seed Village Programme and certified seed production of the Sub-Mission on Seeds and Planting Material (SMSP) under National Mission on Agricultural Extension and Technology (NMAET) during 2016-17 as detailed below.

3. In the letter third read above, the Director of Agriculture has forwarded the revised proposal to Government of India for approval and implementation of the Seed Village Programme during 2017-18 at a total cost of Rs.51.67 crore (Central share Rs.31.00 crore and State share Rs.20.67 crore) as detailed below:-

Since the amount of Rs.432.00 lakh has been dovetailed to Kuruvai Package 2017 and already released under the respective Heads of Accounts vide G.O. second read above, the Director of Agriculture has requested the Government (i) to issue orders to sanction an amount of Rs.901.34 lakh for implementation of SMSP under NMAET during 2017-18 as detailed below:-

7. In G.O. seventh read above, orders have been issued to dovetail an amount of Rs.250.00 lakh for Samba Special Package 2017 from Sub-Mission on Seeds and Planting 2017.

8. The Government after careful examination, accord administrative approval and for an amount of Rs.1333.34 lakh (Rupees Thirteen crore thirty three lakh and thirty four thousand only) (GOI share Rs.800.00 lakh and State share Rs.533.34 lakh) and Financial sanction of Rs.901.34 lakh for implementation of the Seed Village Programme and Certified Seed Production Under Sub-Mission on Seeds & Planting Material under National Mission on Agricultural Extension & Technology during 2017-2018 including Rs.250.00 lakh diverted to Samba Special Package 2017 as per the component wise details given below:-

“2401-00-Crop Husbandry – 796 Tribal Area sub plan – Schemes shared between State and Centre - UM - Production and Distribution of Quality Seeds - 09 Grants-in-Aid-03 Grants for specific schemes”.

10. Necessary additional funds of Rs.25.00 lakh (9.34 lakh + 15.66 lakh) will be provided in Revised Estimate / Final Modified Appropriation 2017-18 under the relevant head of accounts. Pending provision of such funds the Director of Agriculture is permitted to draw and disburse the amount sanctioned in para 7 above. However, the expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate 2017-18. The Director of Agriculture is requested to include this expenditure while sending the proposal for Revised Estimate / Final Modified Appropriation 2017-18 and also to send necessary draft explanatory notes for including the above expenditure in the Supplementary Estimates 2017-18 to Government in Finance (Agri/BG.I) Department at the appropriate time without fail.

11. The Government also ratify the action of the Director of Agriculture in having issued 'Go-ahead' orders to the districts for implementation of the scheme during 2017-2018. The amount realized by way of distribution of seeds to the farmers under Seed Village Programme viz., farmers shall be remitted in Tamil Nadu State Seed Development Agency Savings Bank account.

12. The Director of Agriculture is authorized to draw and disburse the amount under relevant heads of account sanctioned in para 7 above.

13. The Director of Agriculture is directed to follow the guidelines issued by Government of India for Sub-Mission on Seeds & Planting Material while implementing the Seed Village Programme.

14. The Director of Agriculture is requested to ensure that the funds are utilized for the purpose for which it was released (i.e. for General farmers / SC farmers / ST farmers) and no diversion of funds are allowed in any case. He is also directed to ensure that adequate funds are allocated for women farmers.

15. The Director of Agriculture is requested to submit the monthly Physical and Financial Progress Report regularly and Utilization Certificate in the prescribed proforma (GFR-19A) to Government of Tamil Nadu and Government of India.

16. This order issues with the concurrence of Finance Department vide its U.O.No.52851/Agri/2017, dated.25.10.2017 and Additional Sanction Ledger No.1689 (One thousand Six Hundred and Eighty Nine).
