ORDER:

Under Rule 110 of Tamil Nadu Legislative Assembly Rules, the Hon'ble Chief Minister on 18.08.2016 has announced among others, the Samba Special Package Assistance to Delta Districts for the year 2016 on the floor of the Assembly as follows:-

மேட்டூர் அணையில் போதிய அளவு நீர் இல்லாததால் குறுவை நெல் சாகுபடிக்கு ஜூன் 12-ஆம் தேதி தண்ணீர் திறந்து விட இயலவில்லை. நடப்பு கோடை பருவத்தில் 6 டெல்டா மாவட்டங்களில் போதிய அளவு மழை பெய்ததால் நிலத்தடி நீரைக் கொண்டு சாகுபடி மேற்கொள்ள ஏதுவாக 54 கோடியே 65 லட்சம் ரூபாய் மதிப்பிலான குறுவை சாகுபடித் திட்டம் ஒன்றை 1.6.2016 அன்று நான் அறிவித்தேன். இதன் காரணமாக, கணிசமான பரப்பளவில் குறுவை சாகுபடி மேற்கொள்ளப்பட்டுள்ளது.

இயல்பான பருவமழை மற்றும் மேட்டூர் அணைக்கு தேவையான நீர் கிடைக்கப்பெறும்போது டெல்டா மாவட்டங்களில் சம்பா பருவத்தில் நெற்பயிர் சுமார் 14 லட்சத்து 93 ஆயிரம் ஏக்கர் பரப்பில் நாற்று நடவு முறை மூலம் சாகுபடி செய்யப்படும்.

நான் ஏற்கெனவே தெரிவித்தபடி, உச்சநீதிமன்றத்தில் நமக்கு சாதகமான தீர்ப்பினைப் பெற்று, சம்பா சாகுபடிக்கு விரைவில் தண்ணீர் திறக்க முடியும் என நான் நம்புகிறேன். எனினும், ஒரு நல்ல அரசு என்பது எத்தகைய இடர்ப்பாடுகளையும் எதிர்கொள்ளும் வகையில் திட்டங்களை செயல்படுத்தக் கூடிய அரசாக இருக்க வேண்டும். எனவே, எதிர்வரும் வடகிழக்கு பருவமழையிலும், குறைவான மழை மற்றும் நமக்குத் தேவையான அளவு தண்ணீர் மேட்டூர் அணையில் கிடைக்கப் பெறாத சூழ்நிலையிலும், டெல்டா விவசாயிகள் எந்தவித பாதிப்புக்கும் உள்ளாகக் கூடாது என்பதால், சம்பா சாகுபடிக்கென ஒரு சிறப்பு திட்டத்தை எனது தலைமையிலான அரசு செயல்படுத்தும் என்பதைத் தெரிவித்துக் கொள்கிறேன்.

இந்த மாத இறுதிக்குள் சம்பா பயிருக்குத் தேவையான தண்ணீர் மேட்டூர் அணையில் கிடைக்கப் பெறவில்லை எனில், நேரடி நெல் விதைப்பு மூலம் சம்பா சாகுபடி மேற்கொள்வதற்கு ஒரு தொகுப்பு திட்டத்தை எனது தலைமையிலான அரசு செயல்படுத்தும்.

இதன்படி,

- 1) விவசாயிகள் நெல் விதைப்பு மேற்கொள்வதற்காக தரிசு உழவுப் பணிகளுக்கு மானியம் வழங்கப்படும். ஏக்கர் ஒன்றுக்கு 500 ரூபாய் வீதம் இந்த மானியம் வழங்கப்படும். இதற்கென 25 கோடி ரூபாய் நிதி ஒதுக்கீடு செய்யப்படும்.
- 2) விவசாயிகள் தரமான சான்று பெற்ற விதைகள் பெற ஏதுவாக விதைகளுக்கு கிலோ ஒன்றுக்கு, பத்து ரூபாய் மானியம் வழங்கப்படும். இதற்கென 4 கோடியே 50 லட்சம் ரூபாய் நிதி ஒதுக்கீடு செய்யப்படும்.
- 3) இயந்திர முறையில் நெல் விதைப்பு மேற்கொள்ள ஏக்கர் ஒன்றுக்கு 600 ரூபாய் வீதம் மானியம் வழங்கப்படும். இதற்கென 3 கோடி ரூபாய் நிதி ஒதுக்கீடு செய்யப்படும்.
- 4) நேரடி நெல்விதைப்பு மேற்கொள்ளப்படும் இடங்களில், களை பாதிப்பு அதிகளவு இருக்கும் என்பதால் களைக்கொல்லி மருந்து தெளிக்க, ஏக்கருக்கு 280/- ரூபாய் மானியம் வழங்கப்படும். இதற்கென 9 கோடியே 80 லட்சம் ரூபாய் நிதி ஒதுக்கீடு செய்யப்படும்.
- 5) நடவு இயந்திரம் மூலம், நடவு மேற்கொள்ளப்படும் இடங்களில் ஏக்கர் ஒன்றுக்கு 2000/- ரூபாய் வீதம் மானியம் வழங்கப்படும். இதற்கென 20 கோடி ரூபாய் நிதி ஒதுக்கீடு செய்யப்படும்.
- 6) துத்தநாகச் சத்து குறைபாட்டினால் நெல் மகசூல் குறையும் என்பதால், இத்தகைய குறைபாடுள்ள வயல்களில், துத்தநாக சல்பேட் (Zinc Sulphate) பயன்படுத்த ஏக்கருக்கு 200 ரூபாய் வீதம் மானியம் வழங்கப்படும். இதற்கென 2 கோடி ரூபாய் நிதி ஒதுக்கீடு செய்யப்படும்.

மொத்தத்தில் போதுமான தண்ணீர் கிடைக்காத நிலையில், நேரடி நெல் சாகுபடி மேற்கொள்ள வேண்டிய சூழ்நிலையில், நான் தற்போது தெரிவித்தபடி, சம்பா சாகுபடிக்காக 64 கோடியே 30 லட்சம் ரூபாய் மானியம் வழங்கப்படும்.

2. Based on the above announcement of the Hon'ble Chief Minister, the Commissioner of Agriculture in the reference second read above has sent proposals seeking orders for Samba Special Package 2016 to be executed on a mission mode in the Cauvery Delta Districts viz. Thanjavur, Nagapattinam, Tiruvarur and parts of Trichy, Ariyalur, Karur, Pudukkottai and Cuddalore. Further, the Commissioner of Agriculture had, in the reference 2nd read above, permitted the Joint Directors of Agriculture to proceed with the implementation of the components of the Package as announced.

3. The Government, after careful examination, accept the proposal of the Commissioner of Agriculture and accordingly sanction a sum of **Rs.64.30 Crore** (Rupees Sixty four crore and thirty lakh only) for implementation of **Samba Special Package 2016** assistance in Cauvery Delta Districts viz. Thanjavur, Nagapattinam, Tiruvarur and parts of Trichy, Ariyalur, Karur, Pudukkottai and Cuddalore during 2016-2017 as detailed in the Annexure to this order, by strictly adhering to the guidelines of National Agriculture Development Programme, Sub-Mission on Seeds and Planting Materials and National Food Security Mission as specified for implementation of this package.

4. The amount sanctioned in para 3 above shall be sourced as detailed below:-

5. The Government further order that -

- i) the unspent amount of Rs.14.70 Crore remaining with Department of Agricultural Engineering under National Agriculture Development Programme - 2015-16 and Rs.10.30 Crore to be diverted from the component "Popularisation of Machine Planting" under National Agriculture Development Programme - Integrated Food Grain Production Programme for Paddy - 2016-2017 sanctioned vide- G.O.(Ms).No.182, Agriculture (AP1) Department, dated 30.06.2016 - P.P.No.14.1 Integrated Food Grain Production for Paddy (Component No.3) totaling to Rs.25.00 crore shall be utilized for implementation of the component "Ploughing subsidy for taking up direct sowing" under Samba Special Package 2016 as indicated vide - Sl.No.(1) of the Annexure to this order;
- ii) an amount of Rs.3.00 Crore to be sanctioned under Seed Village Programme of Sub-Mission on Seeds and Planting Materials (SMSP) - 2016 - 2017 and Rs.1.50 Crore already sanctioned under National Food Security Mission (NFSM) - Rice - 2016-2017 vide- G.O.(Ms).No.192, Agriculture (AP4) Department, dated 04.07.2016 totaling to Rs.4.50 crore shall be utilized for implementation of the component "Subsidy for distribution of quality certified paddy seeds" under Samba Special Package 2016 as indicated vide- Sl.No.(2) of the Annexure to this order;
- iii) an amount of Rs.3.00 Crore from the component "Popularisation of Machine Planting" under National Agriculture Development Programme - Integrated Food Grain Production Programme for Paddy - 2016-2017 sanctioned vide- G.O.(Ms).No.182, Agriculture (AP1) Department, dated 30.06.2016 - P.P.No.14.1 Integrated Food Grain Production for Paddy (Component No.3) shall be diverted for implementing the component "Subsidy for taking up direct sowing with seed drill" under Samba Special Package 2016. This fund shall be drawn by Chief Engineer (AE) (i/c), Agricultural Engineering Department and apportioned to the Districts as indicated vide-Sl.No.(3) of the Annexure to this order;
- iv) an amount of Rs.9.80 Crore from the component "Popularisation of Machine Planting" under National Agriculture Development Programme - Integrated Food Grain Production Programme for Paddy - 2016-2017 sanctioned vide- G.O.(Ms).No.182, Agriculture (AP1) Department, dated 30.06.2016 - P.P.No.14.1 Integrated Food Grain Production for Paddy (Component No.3) shall be diverted for implementing the component "Subsidy for distribution of Weedicides" under Samba Special Package 2016 as indicated vide- Sl.No.(4) of the Annexure to this order;
- v) an amount of Rs.11.30 Crore available under the component "Popularisation of Machine Planting" under National Agriculture Development Programme - Integrated Food Grain Production Programme for Paddy - 2016-2017 sanctioned vide- G.O.(Ms).No.182, Agriculture (AP1) Department, dated 30.06.2016 - P.P.No.14.1 Integrated Food Grain Production for Paddy (Component No.3) and an amount of Rs.5.00 Crore from the project "Working Capital for reprocessing of Skim Milk Powder to extend life of stocks nearing expiry date under normal RKVY" sanctioned under National Agriculture Development Programme 2015-16 vide- G.O.(Ms).No.59, Agriculture (AP1) Department, dated 9.2.2016 as well as the balance sum of Rs.3.70 crore from second release by the Government of India under National Agriculture Development Programme totaling to Rs.20.00 crore shall be utilized for implementing the component "Subsidy for taking up mechanical transplantation" under Samba Special Package 2016 as indicated vide- Sl.No.(5) of the Annexure to this order;

- vi) an amount of Rs.2.00 Crore from the component "Popularisation of Machine Planting" under National Agriculture Development Programme - Integrated Food Grain Production Programme for Paddy - 2016-2017 sanctioned vide- G.O.(Ms).No.182, Agriculture (AP1) Department, dated 30.06.2016 - P.P.No.14.1 Integrated Food Grain Production for Paddy (Component No.3) shall be diverted for implementing the component "Subsidy for distribution of Zinc Sulphate" under Samba Special Package 2016 as indicated vide- Sl.No.(6) of the Annexure to this order;
- vii) the Director of Agriculture and Chief Engineer (Agricultural Engineering) (i/c) are permitted to obtain necessary ratification from the State Level Sanctioning Committee (SLSC) for the fund diversions ordered under National Agriculture Development Programme (NADP-RKVY).
- viii) the amount proposed for extending assistance shall be back ended subsidy for the following components:-
- Ploughing subsidy for taking up direct sowing @ Rs. 500/- per acre;
 - Subsidy for taking up direct sowing with seed drill @ Rs.600/- per acre, after verifying by officials of Agricultural Engineering Department;
 - Subsidy for distribution of Weedicides @ Rs.280/- per acre;
 - Subsidy for taking up mechanical transplantation @ Rs.2000/- per acre;
 - Subsidy for distribution of Zinc sulphate @ Rs.200/- per acre;

7. The Government further direct that the Commissioner for Milk Production and Dairy Development to surrender an amount of Rs.5.00 crore sanctioned vide G.O. (Ms) No.59, Agriculture (AP1) Department, dated 9.2.2016 and Letter (Ms) No. 139, Agriculture (AP1) Department, dated 28.4.2016 so as to enable the Commissioner of Agriculture to draw and utilize the same for the Samba Special Package 2016.

8. The Director of Agriculture / Chief Engineer (Agricultural Engineering) (i/c) are requested to issue executive guidelines to delta district Joint Directors of Agriculture / Executive Engineers (Agricultural Engineering) for successful implementation of Samba Special Package 2016.

9. Necessary additional funds of Rs.4631.22 lakh will be provided in Revised Estimate / Final Modified Appropriation 2016-2017 under relevant head of account. Pending provision of such funds in the Revised Estimate / Final Modified Appropriation 2016-2017, the Director of Agriculture and Chief Engineer (Agricultural Engineering) (i/c) are authorized to draw and incur the expenditure under relevant heads of account as indicated at para 6 above. However, this expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimates 2016-2017. They are also directed to include this expenditure while sending the proposal for Revised Estimate / Final Modified Appropriation 2016-2017 and also to send necessary draft Explanatory Notes for including the above expenditure in the Supplementary Estimates 2016-2017 to Government in Finance Department without fail.

10. The Chief Engineer (Agricultural Engineering) (i/c) shall send the details of the implementation to the Director of Agriculture and the Director of Agriculture in turn shall send a consolidated weekly progress report on the implementation of the package to Government by every Monday.
