### **ORDER:-**

In Government Order first read above, the Government have sanctioned Rs.324.401 lakh as first instalment for implementation of Paramparagat Krishi Vikas Yojana (PKVY) under National Mission for Sustainable Agriculture (NMSA) 2017-2018 with funding pattern of 60:40 between Central and State Governments.

2. While moving the Demand No.5 – Agriculture on the floor of the Assembly on 12.06.2018, Hon'ble M(A) has made the following Announcement :-

**“To promote organic farming, specific areas would be selected and converted completely to pesticide free organic farming areas and announced as organic farming zones. During 2018-19 such organic farming areas will be promoted at a financial allocation Rs.5.05 crore.”**

3. In the letter second read above, the Government of India have released an amount of Rs.201.96 lakh as first installment for implementing Paramparagat Krishi Vikas Yojana (PKVY) under National Mission for Sustainable Agriculture (NMSA) for the year 2018-19. The above mentioned amount is for 1<sup>st</sup> year activities of 200 new clusters (20 ha each) to the Government of Tamil Nadu for implementation of the Paramparagat Krishi Vikas Yojana (PKVY) scheme during 2018-19.

4. Based on the above release, the Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA) in the letter third read above has sent a consolidated proposal, received from the implementing departments i.e. Director of Agriculture and Director of Horticulture and Plantation Crops. The Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA) has stated that the Government of India have released the 50% Central share of Rs.201.96 lakh (General - Rs.157.5288 lakh (78%), SC – Rs.42.4116 lakh (21%) & ST – Rs.2.0196 lakh (1%)) as first instalment and the corresponding 40% State share works out to Rs.134.640 lakh for the first year activities of 200 new clusters (20 ha each) for the Implementation of Paramparagat Krishi Vikas Yojana component under NMSA during the year 2018-19. The department wise split up details are as below :-

5. The Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA) has therefore requested to sanction an amount of Rs.336.60 lakh including Government of India share of Rs.201.96 lakh and State share of Rs.134.640 lakh as per the proposals given by the implementing Departments viz, Agriculture and Horticulture.

6. After careful examination, the Government accept the proposal of the Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA) and accord sanction a sum of Rs.336.60 lakh (Rupees Three hundred Thirty Six lakh and Sixty thousand only) (Government of India share Rs.201.96 lakh and State share Rs.134.640 lakh) including 2% administrative cost to the Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA), as first instalment for 1<sup>st</sup> year activities of 200 new clusters (20 ha each) for implementation of Paramparagat Krishi Vikas Yojana (PKVY) under National Mission for Sustainable Agriculture (NMSA) scheme on 60:40 sharing basis during 2018-19, as detailed in the Annexure I-III to this order.

7. The expenditure sanctioned in para 6 above shall be debited to the Heads of Account annexed to this order.

8. Necessary additional funds of Rs.125.66 lakhs will be provided in 2018-19 under the relevant heads of account. Pending provision of such funds, the Director of Agriculture and the Director of Horticulture and Plantation Crops are permitted to draw and disburse the amount sanctioned in para 6 above. However, the expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate. The Director of Agriculture and the Director of Horticulture and Plantation Crops are requested to include this expenditure while sending the Budget proposal for RE/FMA 2018-19 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimates 2018-19 to Government in Finance (Agri) Department at the appropriate time without fail.

9. The Director of Horticulture and Plantation Crops will be the Estimating, Reconciling and Controlling authority to the above new heads of account. The Pay and Accounts Officer/Treasury Officers are requested to open the above new heads of account in their Register.

10. The Director of Agriculture is permitted to appoint 30 Cluster Coordinators (Agricultural Graduate) with a provision of Rs.15,000/- per month/ Cluster Coordinator for every 100 Ha cluster for cluster formation, Capacity building, Data Management, Hand holding of groups and clusters, facilitating value addition and marketing and 12 Data entry operators (any Graduate with computer skill) with a provision of Rs.10,000/- per month per Data Entry Operator for every 250 Ha cluster for physical verification, certification endorsement and certification issue from the allocation under the component of Deployment of man power and Service charges to Regional Council (RC) respectively.

11. The Director of Horticulture is permitted to appoint 10 Cluster Coordinator (Horticultural Graduate) with a provision of Rs.15,000/- per month/ Cluster Coordinator for every 100 Ha and 4 Data entry operators with a provision of Rs.10,000/- Data entry operator/ month for every 250 Ha cluster. The finance for appointment of Cluster Coordinator and Data Entry operators would be met under the component of Deployment of Man power and Service Charges to RCs respectively.

12. The concerned Assistant Director of Agriculture is permitted to draw the advance amount as per the provisions for conducting Trainings @ Rs.9,000/ cluster, Exposure visits @ Rs.5,000/ cluster and funds required for Organic fair/ Melas/ Exhibition and exposure visit for lead farmers.

13. The Director of Horticulture is authorized to draw and disburse the amount to the Managing Director, Tamil Nadu Horticulture Development Agency (TANHODA) to implement the project.

14. The Director of Agriculture is authorized to draw the 2% Administrative cost and disburse it to the Executive Director, TAWDEVA for depositing into the savings Bank account for incurring expenditure at Tamil Nadu Watershed Development Agency.

15. The Implementing Departments are requested to scrupulously follow the PKVY Guidelines issued by the Government of India and to follow the cost norms and pattern of assistance while implementing the projects. Further the implementing Departments shall ensure proper implementation of the projects and complete them in time.

16. The Implementing Departments are also requested to monitor the implementation process and progress at the State & District levels effectively and to furnish the monthly progress reports to the Nodal Agency and to the Government simultaneously.

17. The Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA) is requested to send the monthly progress report by 10<sup>th</sup> of the subsequent month and the utilization certificate in the prescribed format to the Government of India under intimation to this Government without fail.

18. This order issues with the concurrence of Finance Department vide its U.O.No. 51932/Agri/2018, dated 30.10.2018 and Additional Sanction Ledger No.1713 (One thousand seven hundred and thirteen).
