Agriculture Department – Provision of Tamil Nadu State Wide Area Network Horizontal connectivity in 18 locations of Agricultural Engineering Department - Payment of Bandwidth recurring charges of Rs.8,95,003/- for the 2nd year (01.07.2017 to 31.03.2018) and 3rd year (01.04.2018 to 31.03.2019) to M/s.Electronics Corporation of Tamil Nadu Limited – Sanctioned – Orders – Issued.

ORDER:

In the Government Order first read above, sanction was accorded to Electronics Corporation of Tamil Nadu Limited (ELCOT) for provision of Tamil Nadu State Wide Area Network (TNSWAN) Horizontal connectivity to the Government Departments at a cost of Rs.40,00,00,000/-.

2. In the Government Order second read above, Government have released a sum of Rs.40,00,00,000/- to Electronics Corporation of Tamil Nadu Limited (ELCOT) for provision of Tamil Nadu State Wide Area Network (TNSWAN) Horizontal connectivity to the Government Departments.

3. In the letter third read above, the Chief Engineer (Agricultural Engineering) has stated that, based on the Government's Order integrating the Government offices by Tamil Nadu State Wide Area Network connectivity for providing data, voice and video facilities for the Departments' applications that are hosted centrally was assigned to Electronics Corporation of Tamil Nadu Limited. Further, supply of hardware charges with 3 year warranty support service and annual bandwidth charges for the first year alone has been sanctioned by the Government and for the subsequent years, the recurring charges has to be borne by the end user Department. The amount of the Band width charges per year shall vary depending on the last mile distance between the nearest Tamil Nadu State Wide Area Network POP to the end user Department and shall be known after the completion of the feasibility survey.

4. He has also stated that the Government in Agriculture Department has directed them to furnish the details of the offices under Agricultural Engineering Department, to be integrated with Tamil Nadu State Wide Area Network along with the details of the contact person (name, designation, phone number and email id) and address of the offices directly to the Electronics Corporation of Tamil Nadu Limited for providing Tamil Nadu State Wide Area Network Horizontal connectivity.

5. Accordingly, 21 Office Locations of their department were furnished to Electronics Corporation of Tamil Nadu Limited to include in the Phase-I operation of Tamil Nadu State Wide Area Network Horizontal connectivity. Based on their request, 18 locations of Agricultural Engineering Department offices are integrated with Tamil Nadu State Wide Area Network Horizontal connectivity out of which 3 locations are connected through Optic Fiber Cable (OFC) and Local Area Network (LAN) from the Offices within the same campus by Electronics Corporation of Tamil Nadu Limited as detailed below:-

Further, the Chief Engineer (Agricultural Engineering) has stated that, in this regard M/s.Electronics Corporation of Tamil Nadu Limited, Chennai has sent two proforma invoices for the recurring charges towards the provision of 2 Mbps bandwidth for the 18 locations of Agricultural Engineering Department offices as detailed below:-

7. Therefore, the Chief Engineer (Agricultural Engineering) has requested to allocate Rs.8,96,000/- over and above the budget estimate 2018-2019 for settlement of the 2nd year (for the period from 01.07.2017 to 31.03.2018) and 3rd year recurring charges (for the period from 01.04.2018 to 31.03.2019) of Rs.8,95,003/- to M/s.Electronics Corporation of Tamil Nadu Limited for provision of Tamil Nadu State Wide Area Network (TNSWAN) Horizontal connectivity to 18 locations of Agricultural Engineering Department.

8. The Government after careful examination, have decided to accept the proposal of the Chief Engineer (Agricultural Engineering) and hereby sanction a sum of Rs.8,95,003/- (Rupees Eight Lakh Ninety Five Thousand Three only) for settlement of the 2nd year recurring charges (from 01.07.2017 to 31.03.2018) and 3rd year recurring charges (from 01.04.2018 to 31.03.2019) to M/s.Electronics Corporation of Tamil Nadu Limited for provision of Tamil Nadu State Wide Area

Network (TNSWAN) Horizontal connectivity to 18 locations of Agricultural Engineering Department.

9. The amount sanctioned in para 8 above shall be debited to the following head of account:-

10. Necessary additional funds of Rs.8,95,003/- will be provided in Revised Estimate / Final Modified Appropriation 2018-2019. Pending provision of such funds, the Chief Engineer (Agricultural Engineering) is authorized to draw and disburse the amount sanctioned in para 8 above to M/s.Electronics Corporation of Tamil Nadu Limited for the provision of Tamil Nadu State Wide Area Network (TNSWAN) Horizontal connectivity to 18 location of Agricultural Engineering Department. The Chief Engineer (Agricultural Engineering) is directed to include the above said expenditure while sending the Budget proposal for Revised Estimate / Final Modified Appropriation 2018-2019 to Finance (Agri./BG.II) Department without fail.
