ORDER:-

The Annual Action Plans for the components under National Mission for Sustainable Agriculture (NMSA) have been furnished to Government of India during March and April 2016 for allocation and release of funds. These proposals have been approved and ratified by the State Level Committee of National Mission for Sustainable Agriculture in its 3rd meeting held on 3.6.2016.

- 2. In the letter second read above, the Government of India have approved Annual Action Plan for an amount of Rs.4000.51 lakh (Government of India Share Rs. 2400.31 lakh and State share Rs.1600.20 lakh) and in the letters first read above the Government of India have released a sum of Rs. 1440.00 lakh as first installment under Rainfed Area Development Component of National Mission for Sustainable Agriculture for the year 2016-17.
- 3. The implementing Departments of the scheme, in their letters third to seventh read above, have sent the proposals of their respective Departments to Government for sanction of funds, based on the 1st installment release made by the Government of India.
- 4. The Government after careful examination, accept the proposals of the Commissioner of Agriculture, Principal Secretary / Commissioner of Horticulture and Plantation Crops, Chief Engineer (Agricultural Engineering), the Principal Secretary/Commissioner of Agricultural Marketing and Agri Business and the Executive Director, Tamil Nadu Watershed Development Agency and accord approval for the proposal of the implementing Departments and sanction Rs.24.00 crore (Rupees twenty four crore only) [Rs.14.40 crore Government of India Share: Rs.9.60 crore State Share] as first installment towards the implementation of the Rainfed Area Development Component under National Mission for Sustainable Agriculture as detailed below:-

The funding pattern of the scheme is 60:40 sharing between the Central and State Governments.

- 5. The expenditure sanctioned in para 4 above shall be debited to the Head of account and component wise details of the projects, as mentioned in the annexure to this order.
- 6. The Commissioner of Agriculture is authorized to draw and disburse the amount sanctioned in para 4 above to the Head of the Departments concerned through Electronic Clearing System (ECS).
- 7. Necessary additional funds of Rs.1,38,49,400/- will be provided in Revised Estimates / Final Modified Appropriation 2016-17 under the relevant head of accounts. Pending provision of such funds, the Commissioner of Agriculture is permitted to draw and disburse the amount sanctioned in para 4 above. However, the expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate 2016-2017. The Commissioner of Agriculture is requested to include this expenditure while sending the proposal for Revised Estimates / Final Modified Appropriation 2016-17 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimates 2016-17 to Government in Finance (Agri/BG-I) Department at the appropriate time without fail.
- 8. The concerned Assistant Directors of Agriculture are permitted to draw an advance amount of Rs.24.50 lakh for conducting training programme at Rs.10,000/per training.
- 9. The Principal Secretary / Commissioner of Horticulture and Plantation Crops is permitted to reallocate the target, based on the requirement and the MD, TANHODA is authorized to operate the account through districts.
- 10. The implementing Departments should scrupulously follow the centrally prescribed cost norms and approved pattern of assistance while implementing the projects and they should take due care to ensure that there is no duplication of subsidy.
- 11. The implementing Departments should ensure proper implementation of the projects and complete them on time. The respective Head of the Departments should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the project.
- 12. The implementing Departments should monitor the implementation process and progress at the State & District levels effectively and to furnish the monthly progress reports to the Nodal Agency and to the Government.
- 13. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the prescribed format by 10th of the subsequent month under intimation to the Government without fail.
