ORDER:

The sale price of the Bio-Control Agents produced in the Bio-Control Labs / Integrated Pest Management Centers are being fixed every year based on the proposal of the Director of Agriculture. Accordingly, in the Government Order first read above, orders were issued fixing the sale price of Bio-Control Agents for the year 2016-17 based on the following formula.

"Production cost of previous year (including staff cost exclusively allotted to this) + margin of 5% on cost of production of previous year.

(or)

Last year sale price, whichever is higher."

Accordingly, for the year 2016-17 the price is fixed as follows:-

- 2. The Director of Agriculture has stated that under the Department of Agriculture, 10 Bio-Control labs and 2 Integrated Pest Management Centres are functioning and they are producing Bio-Control Agents viz., Pseudomonas Fluorescens, Trichoderma Viridi, Nuclear Polyhedrosis Virus. The Bio-Control agents are distributed directly to farmers through Agriculture Extension Centres of the Department.
- 3. Though, the cost of production is expected to be increased this year i.e., during 2017-18, he has proposed to stick on to the last year's sale price considering the competition from private manufactures and Tamil Nadu Agricultural University. Besides, this will motivate farmers to adopt Bio-Control agents at affordable prices. He has, therefore, proposed sale price for the Bio-Control Agents as follows:-

- 4. He has therefore, requested the Government to issue necessary orders for the above sale price for the Bio-Control Agents, for the year 2017-18.
- 5. The Government after careful examination, accept the proposal of the Director of Agriculture and accordingly permit the Director of Agriculture to fix the same price adopted in 2016-17 as sale price of Bio-Control agents viz., Trichoderma Viridi, Pseudomonas Fluorescens, Trichogramma Chilonis, Nuclear Polyhedrosis Virus Spodptera & Helicoverpa produced and distributed to the farmers under various schemes as per the formula. The Government fix the Sale Price of Bio-Control Agents for the year 2017-18 is as detailed below:-
