ORDER:

In the letter 1st read above, The Government of India has released an amount of Rs.322.170 lakh (Rs.257.740 lakh, Rs.61.210 lakh and Rs.3.22 lakh under General, SC and ST Components) as its 60% share as Grants-in-Aid to the Tamil Nadu Government under PMKSY: Other intervention under SSEPERS (ATMA) component of centrally sponsored scheme SMAE under National Mission on Agricultural Extension and Technology (NMAET) during 2015-16.

- 2. The Director of Agriculture in his letter 2nd read above, has stated that the Government of India has introduced the Scheme "Pradhan Mantri Krishi Sinchayee Yojana" during the year 2015-16 with the Objective of Protective irrigation to all agricultural farms in the country to produce "per drop more crop" thus bringing much desired rural prosperity.
- 3. The Director of Agriculture has informed that in order to accomplish the objective of promoting extension services related to water harvesting, water management and crop alignment for farmers and grass root level field functionaries, the Government of India has allocated an amount of Rs.322.170 lakh to Tamil Nadu State under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY): Other interventions for SSEPERS —ATMA during 2015-16, The fund sharing pattern of the scheme is 60%: 40% between Centre and State.
- 4. The Director of Agriculture has therefore requested the Government to release an amount of Rs.536.950 lakh (i.e) Rs.214.780 lakh being the 40% state share and Rs.322.170 lakh being the 60% share released by GOI for implementation of "Pradhan Mantri Krishi Sinchayee Yojana" (PMKSY): Other interventions for SSEPERS-ATMA during the year 2015-16.

- 5. The Government after careful examination, accept the proposal of the Director of Agriculture and accord sanction for release of an amount of Rs. 536.95 lakh (Rupees Five crore Thirty six lakh and Ninety five thousand only) for the implementation of "Pradhan Mantri Krishi Sinchayee Yojana" (PMKSY): Other interventions for SSEPERS-ATMA as per the operational guidelines of "Pradhan Mantri Krishi Sinchayee Yojana" (PMKSY) during the year 2015-16.
- 6. The expenditure sanctioned in para 5 above shall be debited to the Head of Account as mentioned in the Annexure to this order.
- 7. Necessary additional funds of Rs.536.95 lakh will be provided in Final Modified Appropriation 2015-16 under the relevant head of accounts. However this expenditure shall be brought to the notice of the Legislature by way of specific Inclusion in FSE 2015-16. Pending provision of such funds, the Director of Agriculture is authorized to draw and disburse the amount sanctioned in para 5 above. He is also requested to include this expenditure while sending the proposal for Final Modified Appropriation 2015-16 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimates 2015-16 to Government in Finance (Agri) Department at the appropriate time without fail.
- 8. The Director of Agriculture is authorized to draw the entire amount of Rs.536.95 lakh sanctioned in para 5 above and deposit it in the new exclusive ATMA Bank Account for this scheme at Tamil Nadu Watershed Development Agency, the State Level Nodal Agency for release of the amount by means of cheque to the Agricultural Technology Management Agency (ATMA) for implementation of the Scheme.
- 9. The Director of Agriculture is directed to follow the operational Guidelines of SMAE and PMKSY while implementing the above scheme.
- 10. This order issues with the concurrence of Finance Department vide its U.O.No.69753/Agri/2015, dated: 08.01.2016 and with Additional Sanction Ledger No.1881 (One Thousand Eight Hundred and Eighty one)
