ORDER:

In the Government order first read above, the Government issued orders enhancing the Processing and Tagging charges for seeds from 40 paise per one Kg to 60 paise per one Kg with immediate effect for a period of three years.

2. The Director of Agriculture in his letter second read above has stated that the processing charges at Government Seed Processing Units for one kg of Paddy, Millets, Pulses and Oilseeds for Rs.0.60/- per kg i.e., Rs.600/- per MT, includes both processing charges and tagging charges which is fixed in the year 2012 and valid for 3 years only. Hence, the Director of Agriculture has requested for enhancing seed processing and tagging charges to Rs.1.45/- per kg from present charge of Rs.0.60/- per kg in view of repeated requests made by farm labourers who are engaged in Seed Processing Units (SPU). The break up for Rs.1,450/- per MT is given as follows:

1. Processing Charges for one tonne Rs.825/-

2. Tagging Charges for one tonne Rs.550/-

3. EB Charges for one tonne Rs.75/-

Total Rs.1,450/-

3. After careful examination of the proposal of the Director of Agriculture, the Government issue orders enhancing the processing and tagging charges for the

seeds from existing 60 paise per Kg to 90 paise per Kg with effect from the date of issue of order for the forthcoming next three years.
