Horticulture - Pradhan Mantri Fasal Bima Yojana (PMFBY) - Sanction of Rs.104.74125 lakh for settlement of State share of premium subsidy to the Insurance Companies for Kharif season during 2016-17 - Orders - Issued.

ORDER:-

In the Government order first read above, the Government among others, have accorded administrative approval for the implementation of PMFBY at a cost of Rs.487.3703 Crore in all the districts of Tamil Nadu (except Chennai) from Kharif 2016 onwards by replacing National Agricultural Insurance Scheme (NAIS) and authorised the Commissioner of Agriculture and the Commissioner of Horticulture and Plantation Crops to disburse 50 % of the fair estimate of the premium subsidy based on the claims of the successful bidder to the approved insurance companies through Agriculture Insurance Company of India Limited following the Government of India subsidy pattern in the selected cluster at the beginning of crop season and the balance premium claim on the closure of the season based on the claims of the approved insurance companies and it has also been ordered that the financial sanction would be accorded by the Government, after receiving the claim from the insurance companies selected through the tender along with the proposal from the Commissioner of Agriculture and the Commissioner of Horticulture and Plantation Crops as per the guidelines issued by the Government of India.

2) In the letter second read above, the Director of Horticulture and Plantation Crops has now informed that notification was issued for both Kharif and Rabi seasons for implementation of PMFBY during 2016-2017 and the following companies have been selected for implementation of the scheme in Tamil Nadu during 2016-2017, 2017-2018 and 2018-2019 followed by the tender process:-

3) Further the Director of Horticulture and Plantation Crops has stated that as per the operational guidelines, the State Government has to release 50% of their share as upfront subsidy based on the fair estimates of the insurance companies. The cut-off date for enrolment of and to authorize her to draw and disburse the amount to the concerned Insurance Companies.

- 6) The Government after careful examination of the proposal of the Director of Horticulture and Plantation Crops, accord sanction for a sum of Rs.104.74125 lakh(Rupees One Crore Four lakh Seventy Four thousand One hundred and Twenty Five only) for settlement of State share of premium subsidy to the concerned Insurance Companies for Kharif season during 2016-17 under PMFBY.
- 7) The amount sanctioned in para 6 above shall be debited in the following heads of account:-

farmers in Kharif season was July 31st for Paddy I crop and 30th September for other crops. Based on the enrolment of farmers during Kharif season, the three companies have raised their claim to settle the State share of premium for Kharif 2016 season. As the orders were issued during the midst of Kharif season, upfront subsidy was not settled to the companies. The Director of Horticulture and Plantation Crops has also stated that during the video conference conducted by the Joint Secretary (Credit division), Government of India on 13.10.2016, it was requested to finalize the Kharif 2016 enrolment on 20.10.2016 and raise the actual claims after finalizing the data for Kharif 2016. Therefore, the insurance companies were requested to send their actual claim for settlement of State share of premium subsidy for Kharif 2016 season. Accordingly, they have claimed the State share of premium for Kharif season, based on the actual coverage in Kharif during 2016-2017.

4) The Director of Horticulture and Plantation Crops has furnished the details of the State share of premium subsidy claimed by the Companies based on the operational guidelines of PMFBY for Kharif season during 2016-17 which are as follows:-
