

Agriculture – National Agricultural Insurance Scheme - Sanction of Rs.4,97,26,508/- for settlement of pending State share of premium to Agriculture Insurance Company of India Ltd., for Rabi 2015-2016 (Horticulture crops) - Orders – Issued.

## **ORDER:**

In the Government Order first read above, among others, orders have been issued for sanction of a sum of Rs.9.50 Crore towards the payment of 50% premium subsidy for Loanee and Non-Loanee farmers including tenant farmers for Horticulture Crops under National Agricultural Insurance Scheme during 2015-2016.

- 2) Subsequently, in the Government Order second read above, among others, orders have been issued according administrative approval for the implementation of Pradhan Mantri Fasal Bima Yojana at a cost of Rs.487.3703 crore in all the districts of Tamil Nadu (except Chennai) from Kharif 2016 onwards by replacing the existing National Agricultural Insurance Scheme.
- 3) In the letter third read above, the Director of Horticulture and Plantation Crops has stated that National Agricultural Insurance Scheme was implemented in the all Districts of Tamil Nadu (except Chennai) during 2015-2016. In G.O.(Ms) No.220, Agriculture (AP6) Department, dated 21.07.2016, Government have authorized only for the settlement

of State share of premium subsidy to the insurance companies selected to implement Pradhan Mantri Fasal Bima Yojana in Tamil Nadu. Now the authorization is required for settlement of pending State share of premium and Bank Charges under National Agricultural Insurance Scheme for Rabi season of 2015-16.

4) The Director of Horticulture and Plantation Crops has also furnished the details of the claims pending for settlement to the Agricultural Insurance Company of India Limited as follows:-

- 5) The Director of Horticulture and Plantation Crops has requested the Government to sanction an amount of Rs.497.26508/- lakh towards settlement of pending State share of premium subsidy and Bank Service Charges for Rabi 2015-2016 under National Agricultural Insurance Scheme and to authorize her to settle the same to Agricultural Insurance Company of India Limited during the year 2016-17.
- 6) The Government after careful examination of the proposal of the Director of Horticulture and Plantation Crops, accord sanction for a sum of

Rs.4,97,26,508/- (Rupees four crore ninety seven lakh twenty six thousand five hundred and eight only) towards settlement of pending State share of premium subsidy and Bank Service Charges for Rabi 2015-2016 under National Agricultural Insurance Scheme to Agricultural Insurance Company of India Limited during the year 2016-17.

7) The amount sanctioned in para 6 above shall be debited to the following heads of account:-

- 8) Necessary funds will be provided in Final Modified Appropriation 2016-2017 under the relevant heads of account. Pending provision of such funds, the Director of Horticulture and Plantation Crops is permitted to draw and disburse the amount sanctioned in para 6 above. However, the expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate. The Director of Horticulture and Plantation Crops is requested to include this expenditure while sending the proposal for Final Modified Appropriation 2016-2017 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimates 2016-17 to Government in Finance (Agri/BG-1) Department at the appropriate time without fail.
- 9) This order issues with the concurrence of Finance Department vide its U.O. No.6678/Fin(Agri)/2017, dated 13.02.2017 and ASL No.2102 (Two thousand one hundred and two).
