ORDER:-

In the Government order first read above, administrative approval has been accorded for implementation of the Coconut Development Board assisted scheme in Tamil Nadu during 2018-2019 (Production and Distribution of Planting materials, Expansion of Area under Coconut, Integrated farming for productivity improvement, Coconut Palm Insurance scheme, Replanting and Rejuvenation of old coconut gardens) at an outlay of Rs.1487.93 lakh of which, the share of Coconut Development Board, Kochi is Rs.1423.93 lakh and the share of the State Government is Rs.64.00 lakh. Accordingly, funds have been released along with State's share.

2. In the letter seventh read above, the Director of Agriculture has stated that During November 2018, large scale devastation was caused by Gaja cyclone (16-11-2018) to nearly 45,117 ha of coconut gardens, causing permanent damage to around 63 lakh coconut trees in eight districts of Tamil Nadu. Hence, the Government of

India, have been requested for financial sanction for Rs.630.00 crore which includes supply of coconut seedlings free of cost (for Rs.30 Crore) and assistance for Cut and Removal of damaged coconut trees (Rs.600 Crore) directly to Tamil Nadu or through Coconut Development Board.

3. The Coconut Development Board has now conveyed its approval of "Special package to mitigate the loss incurred by Gaja Cyclone in Tamil Nadu" for implementation in 2018-19 in the Gaja affected districts for an amount of Rs.92.00 crore and requested to convey State Level administrative approval for the above scheme. The Coconut Development Board has also released a sum of Rs.80.00 crore for this.

- 5. The Director of Agriculture has requested to accord Administrative sanction orders for the implementation of the scheme, "Special package to mitigate the loss incurred by Gaja Cyclone in Tamil Nadu" in 2018-19 in the Gaja affected districts for an amount of Rs.92.00 crore.
- 6. The Coconut Development Board has, earlier released a sum of Rs.13.425 crore for implementation of Coconut Development Board (CDB) assisted scheme of Replanting and Rejuvenation scheme under Scheduled Caste Sub Plan (SCSP) category in Gaja Cyclone affected areas in Tamil Nadu for the year 2018-2019 and a sum of Rs.10,00,16,250/- as relief for coconut trees affected by Gaja cyclone for cutting and removal of palms, Rejuvenation and for Replanting. Financial sanction to the extent of Rs.10,00,16,250/- and Rs.13,42,50,000/- have been accorded in the Government order fifth and sixth read above respectively.
- 7. The Government after careful examination of the proposal of Director of Agriculture, accord administrative sanction for an amount of Rs.92.00 crore (Rupees Ninety two crore only) towards implementation of the scheme "Special package to mitigate the loss incurred by Gaja Cyclone in Tamil Nadu" in 2018-19 in the Gaja affected Districts as approved by the Coconut Development Board.

- 8. The amount to be sanctioned in para 7 above shall be debited to the following heads of account:-
