ORDER:-

The following amendment is issued to the G.O.(Ms) No.3, Agriculture (WD 2) Department, dated 5.1.2018:-

AMENDMENT

(i) For the existing second and third lines i.e. "the Project beneficiaries are farmers including small and marginal, Water Users Associations, Farmer Producer Organisation and other entrepreneurs" in para 2 of the said Government Order, the following lines shall be substituted:-

"the beneficiary for the construction of Farm Pond is selected based on the willingness of the land owning farmers".

(ii) For the existing seventh to tenth lines, "Since, the Farm Ponds are constructed inside the Farmer's lands, the conveyance loss is minimized due to localized irrigation, improving the water use efficiency and thus additional income for farmers can be provided due to fish culture is possible there" in para 2 of the said Government Order, the following lines shall be substituted:-

(P.T.O)

"Since the Farm Ponds are constructed inside the Farmer's lands, the conveyance loss is minimized due to localized irrigation, improving the water use efficiency and also an additional income for farmers can be obtained due to fish culture, if the farmers opt for it, when water is stored for more than 4 months".
