ORDER:-

In the Union Budget 2019, the Government of India have announced launching a new Central Sector Scheme, namely "Pradhan Mantri Kisan SAmman Nidhi (PM-KISAN)" to extend financial assistance of Rs.6,000/- per year (Rs.2,000/- each for four months) to all small and marginal farmer families having total cultivable holding of upto 2 hectares and communicated the operational guidelines for the scheme.

- 2. Based on that, in the G.O. read above, the Government have issued orders for implementing the above scheme in the State of Tamil Nadu with effect from 01.12.2018 and for this scheme, the Department of Agriculture is the nodal department. The Additional Chief Secretary / Commissioner of Revenue Administration had been appointed as the Nodal Officer and Agricultural Production Commissioner and Principal Secretary to Government as the Secretariat Nodal Officer. The Executive Director, Tamil Nadu Watershed Development Agency has been nominated as Nodal Agency for receiving funds and for coordinating with the Nodal Officer, Nodal Bank and District administration.
- 3. In partial modification of the orders issued in the G.O. read above, the Government direct that the Additional Chief Secretary / Commissioner of Revenue Administration shall be the State Coordinating

Officer who is responsible for monitoring the Scheme implementation by the field level officials in the districts and the Director of Agriculture shall be the State Nodal Officer for operational implementation of scheme, "Pradhan Mantri Kisan SAmman Nidhi (PM-KISAN)". The Director of Agriculture will create the login ID in PM-KISAN Portal as the State Nodal Officer and carry out the related responsibilities in this regard.
