ORDER:

In the Government Order first read above, the administrative approval has been accorded to Tamil Nadu Agricultural University, Coimbatore for the establishment of a new Horticultural College and Research Institute for Women at Navalur Kuttapattu of Srirangam constituency, Tiruchirappalli District at an estimated cost of Rs.40.00 Crore spread over for four years.

2. In the Government Order second read above, an amount of Rs.10.00 Crore was sanctioned for the first year (2011-12) i.e Rs. 2.3 Crore for current expenditure and Rs. 7.7 Crore for the capital expenditure for construction of buildings, students amenities, etc., to Tamil Nadu Agricultural University for the establishment of Horticultural College and Research Institute, Navalur, kuttapattu, Trichirapalli District.

3. In the Government Order third read above, the Registrar, Tamil Nadu Agricultural University has been directed to entrust the construction work of Horticultural College and Research Institute for Women at Tiruchirappalli to Public Works Department.

4. In the Government Order fourth read above an amount of Rs.10.65 Crore was sanctioned for the second year (2012-13) i.e Rs. 3.80 Crore for current expenditure and Rs. 6.85 Crore for the capital expenditure for construction of building, student amenities, etc., to Tamil Nadu Agricultural University for the establishment of Horticultural College and Research Institute for Women at Tiruchirappalli.

5. In the Government Order fifth read above, a sum of Rs.5.25 Crore intended for III year (2013-14) has been sanctioned and released to Tamil Nadu Agricultural University.

6. In the letter sixth read above, the Registrar, Tamil Nadu Agricultural University has requested the Government to re-appropriate the amount of Rs.5.25 Crore sanctioned for the capital works for the year 2013-14 as detailed below:-

The Registrar, Tamil Nadu Agricultural University has stated that considering the immediate need of the College without compromising the proposed requirements, a sum of Rs.3.87 Crore is proposed for library building and 1.38 Crore for construction of staff quarters without exceeding the sanctioned budget of Rs.5.25 Crore for the year 2013-14. The budget proposed for staff quarters of Rs.1.38 Crore is sufficient to meet out their requirements. The other facilities like Field Lab and Instructional Farm development will be created in 2014-15 grants without omitting any facilities already proposed in the proposal within the allocated budget.

8. The Government after careful consideration of the request of the Registrar, Tamil Nadu Agricultural University has decided to accept it. Accordingly, the Registrar, Tamil Nadu Agricultural University is permitted to reallocate the amount of Rs.5.25 Crore sanctioned for the capital works for the year 2013-14 as detailed below:-


