ORDER:

During the 12th State Level Sanctioning Committee meeting of National Agriculture Development Programme held on 14.11.2014 under the chairmanship of Chief Secretary to Government, the following project proposal of Department of Agricultural Marketing and Agri Business was approved:-

2. On 07.08.2014, under Rule 110 of the Tamil Nadu Legislative Assembly, among others, Hon'ble Chief Minister has made an announcement that to ensure protein security in the State, Redgram cultivation would be promoted in a Mission mode by increasing the area of cultivation, by use of various advanced technologies and by forming farmer clusters. These clusters would be integrated to form FPOs.

Action will be taken to procure the Redgram by Tamil Nadu Civil Supplies Corporation and by Co-operation Department at reasonable prices.

- 3. The Government of India have allocated Rs.279.95 crore under normal RKVY to the State of Tamil Nadu for the year 2014-15 and Rs.19.00 crore under sub-scheme.
- 4. Based on the approval of 12th State Level Sanctioning Committee and observation of Central Small Farms' Agriculture Business Consortium (SFAC), the Director of Agricultural Marketing and Agri Business has sent the revised proposal restricting the total project cost to Government for issue of orders:-

- 5. The Government, after careful examination, approve the detailed project proposal for Promotion of 10 Farmer Producer Organizations for attaining self sufficiency in Pulses and Regram at a cost of Rs.426.72 lakh which will be implemented over a period of three years and sanction an amount of Rs.50.75 lakh (Rupees Fifty lakh and seventy five thousand only) for 1st year activities under National Agriculture Development programme / Rashtriya Krishi Vikas Yojana for 2014-15 for the above purpose to the implementing agency i.e. Department of Agricultural Marketing and Agri Business subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted.
- 6. The expenditure sanctioned in para 5 above shall be debited in the head of account as mentioned in the annexure to this orders.
- 7. The Government direct that Ten Pulses FPOs shall be formed in the Districts of Nagapattinam, Madurai, Villupuram, Thiruvannamalai, Vellore, Krishnagiri, Pudukottai, Dharmapuri, Thanjavur and Salem.
- 8. Necessary additional funds will be provided in Final Modified Appropriation 2014-15 to meet the expenditure sanctioned in para 5 above by the way of re-appropriation under the head of account 2401-00-800-KF-11-01. However, the expenditure shall be brought to the notice of the Legislative by way of specific inclusion in FSE 2014-15. Pending provision of such funds Final Modified Appropriation 2014-15, the Director of Agricultural Marketing and Agri Business is permitted to draw the amount sanctioned in para 5 above. The Director of Agricultural Marketing and Agri Business is requested to include this expenditure while sending proposal for Final Modified Appropriation 2014-15 and also to send necessary Explanatory Notes for including the above expenditure in the Supplementary Estimates 2014-15 to Finance (Agri/BG-I) Department without fail.
- 9. The Director of Agricultural Marketing and Agri Business is directed to place above proposal before the next SLSC for ratification.

- 10. The funds available under existing Centrally Sponsored Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above project. The project should follow centrally prescribed cost norms and approved pattern of assistance. The Department of Agricultural Marketing and Agri Business should take due care to ensure that there is no duplication of subsidy.
- 11. The Director of Agricultural Marketing and Agri Business should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the scheme.
- 12. The Director of Agricultural Marketing and Agri Business to follow the operational guidelines of NADP while implementing the above scheme.
- 13. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the HOD's concerned to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.
- 14. The Executive Director, Tamil Nadu Watershed Development Agency to send the monthly progress report to Government of India, in the prescribed format by 10th of the subsequent month under intimation to this Government without fail.
- 15. This order issues with the concurrence of Finance Department vide its U.O.No.4796/Agri/2015, dated.20.2.2015 and Additional Sanction Ledger No.2523 (Two thousand five hundred and twenty three).
