ORDER:

In the Government Order first read above, the Government have accorded administrative approval for execution of 15 New Road Works including one high level bridge under Sugarcane Road Development Scheme during 2013-14 at a cost of Rs.1965.70 lakh subject to the condition that the works should be executed keeping the fund availability in view.

2. Among the above said 15 road works, one work @ S.No.15 viz. "forming and improving road from between Alagapuri and Rajathottam branching @ Km.200/4 of NH 208 Km 0/0 to 1/8" was sanctioned for a length of 1.80 Km at a cost estimate of Rs.183.00 lakh indicating the name of Sugar Mills as Dharani Sugars, Vasudevanallur. Subsequently, amendment orders have been issued to change the road work to National Cooperative Sugar Mills, Alanaganallur instead of Dharani Sugars, Vasudevanallur in the Government Order second read above, subject to the condition that the above matter has to be rectified in the next Cess Fund Utilization Committee meeting. Accordingly, this was ratified by the Cess Fund Utilization Committee meeting held on 26.04.2016.

3. The Director of Sugar has now informed that the said work was completed during 2016-17 for which the expenditure incurred was only Rs.23.96 lakh (Rs.6.89 lakh during 2015-16 & Rs.17.07 lakh during 2016-17) and the Chief Engineer (Highways) has requested allocation of the balance amount of Rs.135.22 lakh in the budget 2018-19.

4. The Director of Sugar has therefore requested the Government to sanction the balance amount of Rs.135.22 Lakh at the earliest.

5. The Government, after careful examination, accept the request of the Director of Sugar and accord sanction for a sum of Rs.1,35,22,000/- (Rupees One Crore Thirty Five Lakh and Twenty Two Thousand only) in connection with road work viz., forming and improving a road between Alagapuri and Rajathottam (@ Km 200/4 of NH 208 KM 0/0 to 1/8)" at an outlay of Rs.183.00 lakh for the length of 1.80 Km in the demarcated area of National Co-operative Sugar Mills, Alanaganallur so as to settle the payment for the work already completed in the year 2016.

6. The expenditure sanctioned in para 5 above shall be debited under the following head of account:-

"5054-Capital Outlay on Roads and Bridges – 05- Roads -337 Road Works – State's Expenditure – JB - Improvement of Roads -16 Major Works." (DPC 5054-05-337-JB-1604).

7. The Chief Engineer (Project), Highways, is authorized to draw and disburse the amount sanctioned in para 5 above.

8. This order issues with the concurrence of Finance (Industries) Department, vide its U.O.No.5672/2019, Dated: 26.2.2019.
