#### **ORDER :-**

In W.P.(Civil) No.350/1993 filed by Islamic Academy of Education and another Vs. State of Karnataka and others, the Hon'ble Supreme Court of India has delivered clarificatory judgment on 14.08.2003. The

Hon'ble Supreme Court, among other things, has directed to constitute a Committee, headed by a retired Judge of the High court, for fixation of fee for the students admitted into un-aided Private Professional Educational Institutions (Minority and Non-Minority).

2. By virtue of Section 2 (e) of the Tamil Nadu Admission in Professional Educational Institutions Act, 2006 (Tamil Nadu Act 3 of 2007), orders were issued in G.O. 3<sup>rd</sup> read above, notifying all Courses in Agriculture and allied subjects at Under Graduate level as professional educational courses and the same was published in the Tamil Nadu Government Gazette. The Government have also framed the Tamil Nadu Admission in Agricultural Institutions Rules, 2007 and these rules were also published in Tamil Nadu Government Gazette.

3. In the reference 10<sup>th</sup> read above, the Registrar-cum-Special Officer (Liaisoning), High Court of Madras has stated that the Hon'ble Chief Justice of Madras High Court is pleased to nominate **Hon'ble Mr. Justice K. Chandru (Retd. Judge of High Court of Madras) to head the Committee on Fixation of Fee mentioned in para 1 above.**

4. In pursuance, the Government now direct that a Committee on Fixation of fee in respect of private colleges of Agriculture and allied subjects affiliated to Tamil Nadu Agricultural University (Minority and non-minority) be constituted as follows:-
