ORDER:

The Hon'ble Chief Minister has made an announcement under Rule 110 of Tamil Nadu Legislative Assembly that Ladies Hostel with all the facilities will be constructed in Tamil Nadu Agricultural University at a total cost of Rs.22.95 crore. Accordingly, based on the proposal of the Registrar, Tamil Nadu Agricultural University, in the Government Order 3rd read above Administrative Sanction was accorded to Tamil Nadu Agricultural University for construction of ladies hostels in the Four constituent colleges of Tamil Nadu Agricultural University, i.e Agricultural College and Research Institute

(AC&RI), Coimbatore, Horticultural College & Research Institute, Coimbatore, Agricultural Engineering College & Research Institute, Coimbatore, Horticultural College & Research Institute (Women), Trichy at a total cost of Rs.25 crore with loan assistance from NABARD under Rural Infrastructure Development Fund -XXI for the year 2015-16.

2. In the letter 4th read above, the Deputy General Manager, National Bank for Agricultural and Rural Development (NABARD) has stated that the Rural Infrastructure Development Fund (RIDF) Internal Sanctioning Committee (ISC) in its 9th meeting held on 14th January 2016 has sanctioned an amount of Rs.2124.14 lakh for construction of ladies hostels in the Four constituent colleges of Tamil Nadu Agricultural University, i.e Agricultural College and Research Institute (AC&RI), Coimbatore, Horticultural College & Research Institute, Coimbatore, Agricultural Engineering College & Research Institute, Coimbatore, Horticultural College & Research Institute (Women), Trichy.

3. The Government after careful consideration, sanction a sum of Rs.424.828 lakh (Rupees Four crore twenty four lakh eighty two thousand and eight hundred only) as mobilization advance for construction of ladies hostels in the Four constituent colleges of Tamil Nadu Agricultural University, i.e Agricultural College and Research Institute (AC&RI), Coimbatore, Horticultural College & Research Institute, Coimbatore, Agricultural Engineering College & Research Institute, Coimbatore, Horticultural College & Research Institute (Women), Trichy.

4. The expenditure sanctioned in para 3 above, shall be debited to the following Head of Account:-

2415 - Agricultural Research and Education -01- Crop Husbandry - 120- Assistance to other Institutions - Schemes in the 12th Five year plan - II State Plan - JA - Grants to Tamil Nadu Agricultural University 09. Grants-in-Aid.-02. Grants for Creation of Capital Assets.

(DPC 2415-01-120-JA- 0921).

5. Necessary funds will be provided in Final Modified Appropriation 2015-16 to meet the expenditure sanctioned in para 3 above. Pending provision of such funds, in Final Modified Appropriation 2015-16, the Director of Agriculture, Chennai is authorized to draw and disburse the amount. However this expenditure shall be brought to the notice of legislature by specific inclusion in the Final Supplementary Estimate. The Director of Agriculture is directed to include this item of expenditure sanctioned above while sending Budget Proposal for Final Modified Appropriation 2015-16 and also to send necessary draft explanatory notes for inclusion of the above expenditure in the Final Supplementary Estimates 2015-16 to Government in Finance (Agriculture) Department without fail.

6. The Registrar, Tamil Nadu Agricultural University is directed to implement the construction work by following the existing Financial Procedures / Government Orders while incurring the expenditure sanctioned in para 3 above. He is also directed to inform the progress of the work and expenditure made every month to Government.

7. This order issues with the concurrence of Finance Department vide its U.O. No.4561/Agri/16, dated 05.02.2016 and Additional Sanction Ledger No.2148 (Two Thousand one Hundred and Forty Eight).
