Agriculture - National Agricultural Insurance Scheme – Sanction of Rs.2,38,013/- towards settlement of State Government share of compensation claims for Maize Crop of Rabi 2015 – 2016 under National Agricultural Insurance Scheme – Orders – Issued.

ORDER:

In the Government Order first read above, orders were issued for implementation of National Agricultural Insurance Scheme during 2015-2016 and an amount of Rs.30.0062 crore was sanctioned towards payment of 50% premium subsidy for loanee and non-loanee farmers including tenant farmers for agricultural crops and expenditure towards advertisement and contingencies.

2. In the Government Order second read above, sanction was accorded for a sum of Rs.22.346 crore towards the settlement of pending State share of premium subsidy and bank charges for Kharif, 2015 and Paddy II (S/T/P) 2015-2016 season under National Agricultural Insurance Scheme to Agriculture Insurance Company of India Limited during the year 2016-2017.

3. In the Government Order third read above, sanction was accorded for a sum of Rs.10.4106 crore towards the settlement of State share of premium subsidy and bank charges for Rabi, 2015-2016 under National Agricultural Insurance Scheme to Agriculture Insurance Company of India Limited during the year 2016-2017.

4. In the Government Order fourth read above, orders were issued sanctioning a sum of Rs.168,65,95,729/- towards the settlement of State share of compensation claims for Paddy II (S/T/P) Rabi season under National Agricultural Insurance Scheme for the year 2015-2016.

5. In the Government Order fifth read above, orders were issued sanctioning a sum of Rs.9.207 crore towards the settlement of State share of compensation claims for other Rabi Crops under National Agricultural Insurance Scheme for the year 2015-2016.

6. The Director of Agriculture in his letter sixth read above has stated that the Agriculture Insurance Company of India Limited, Chennai has informed that the compensation claims worked out earlier for maize crop were based on the yield data furnished by Department of Economics & Statistics at State level for 45 Notified units and now the claim has been reworked based on the yield data furnished at firka level (Actual notified unit) as per the advice of the competent authority. The Agriculture Insurance Company of India Limited which had earlier reported compensation claims of Rs.15,40,790.26 based on the State level yield data for maize crop insured during Rabi 2015-16 under National Agricultural Insurance Scheme (NAIS) has now reworked the claims with firka level yield data and a sum of Rs.20,16,815.98 has been reported as the final claim for maize crop by Agriculture Insurance Company of India Limited. Hence, the difference amount of Rs.4,76,025.72 (Rs.20,16,815.98 – Rs.15,40,790.26) has to be equally borne by the State and Central Government and requested to release the differential sum of State share of compensation claims of Rs.2,38,013/- .

7. The Director of Agriculture has, therefore, requested the Government to sanction the differential sum of State share of Rs.2,38,013/- towards the payment of compensation for maize crops of Rabi 2015 -2016 season under National Agricultural Insurance Scheme.

8. The Government, after careful examination of the above proposal of the Director of Agriculture have decided to accept the same. Accordingly, the Government sanction a sum of Rs.2,38,013/- (Rupees Two Lakh Thirty Eight Thousand and Thirteen only) as State share of compensation towards the payment of differential sum of compensation claims for maize crops of Rabi 2015 - 2016 season under National Agricultural Insurance Scheme.

9. The expenditure sanctioned in para 8 above shall be debited to the following head of account:-
