ORDER:-

Based on the Fair and Remunerative Price announced by Government of India for 2015-16 sugar season as Rs.2,300/- per M.T., in the G.O first read above, the Government have fixed State Advised Price for 2015-16 as Rs.2,850/- per M.T.

2. The Government of India vide their letter read above have fixed the Fair and Remunerative Price (FRP) for sugarcane for 2016-17 season at Rs.2,300/- per M.T. linked to average recovery of 9.5% with an incentive of Rs.24.20 per M.T. for every increase of 0.1% recovery over and above 9.5% average recovery.

3) After careful consideration, the Government fix the State Advised Price for sugarcane for 2016-17 Sugar season at Rs.2,850/- per M.T. including Rs.100/- per M.T. towards transportation charges for sugarcane being supplied to sugar mills in Tamil Nadu linked to 9.5% average recovery with an incentive of Rs.24.20 per M.T. for every increase of 0.1% recovery over and above 9.5% average recovery taking into consideration of Fair and Remunerative Price announced by the Government of India at Rs.2,300/- for 2016-17 Sugar season.


