### ORDER:

In the Government Order 3<sup>rd</sup> read above, the Government have accorded administrative sanction for a sum of Rs.155.42 lakh and financial sanction for a sum of Rs.77.71 lakh towards implementation of the project proposals of the Department of Seed Certification & Organic Certification under National Agriculture Development Programme 2016 - 17.

2. In the letter 4<sup>th</sup> read above, the Government of India have released additional fund of Rs.50.00 crore as its 60% share under National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana 2016-17 for completion of ongoing projects approved by the State Level Sanctioning Committee of the State in its meeting held on 19.02.2016. The corresponding 40% State share is Rs.33.33 crore.

3. Therefore, as requested earlier by the Director of Seed Certification & Organic Certification, now, the Executive Director, Tamil Nadu Watershed Development Agency has requested the Government to provide authorization for the remaining amount of Rs.77.71 lakh towards 2<sup>nd</sup> installment implementation of the following projects under National Agriculture Development Programme, 2016-17:-

4. The Government after careful examination of the proposal of the Department of Seed Certification and Organic Certification, accord financial sanction for a sum Rs.77.71 lakh (Rupees Seventy seven lakh and Seventy one thousand only) as 2<sup>nd</sup> installment towards implementation of the above proposals of the Department of Seed Certification & Organic Certification under National Agriculture Development programme / Rashtriya Krishi Vikas Yojana 2016-17. The funding pattern of the scheme is 60:40 sharing basis between the Centre and the State Governments.

5. The funds available under existing Centrally Sponsored / Central Sector Schemes should invariably be lapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above projects. The projects should follow centrally prescribed cost norms and approved pattern of assistance. The Director of Agriculture should take due care to ensure that there is no duplication of subsidy.

6. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account:-

7. Necessary additional funds will be provided in Final Modified Appropriation 2016 - 17 under the relevant heads of account. Pending provision of such funds, the Director of Seed Certification and Organic Certification is permitted to draw and disburse the amount sanctioned in para 4 above. However, the expenditure shall be brought to the notice of Legislature by a specific inclusion in the Supplementary Estimates. He is also requested to include this expenditure while sending the proposal for Final Modified Appropriation 2016 - 17 and also to send necessary explanatory notes for including the above expenditure in the FMA 2016 - 17 to the Government in Finance (Agri/BG.I) Department at the appropriate time without fail.

8. The Director of Seed Certification & Organic Certification is authorized to draw and disburse the amount sanctioned in para. 4 above to the concerned.

9. The Director of Seed Certification & Organic Certification should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the schemes.

10. The Director of Seed Certification & Organic Certification shall observe the comments / suggestions of State Level Sanctioning Committee while implementing the projects.

11. The Director of Seed Certification & Organic Certification is directed to follow the respective operational guidelines while implementing the schemes.

12. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the Head of Departments' to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.

13. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the prescribed format by 10<sup>th</sup> of the subsequent month under intimation to the Government without fail.
