#### ORDER:

In the Government order 3<sup>rd</sup> read above, the Government have accorded administrative sanction for a sum of Rs.19106.025 lakh and financial sanction for a sum of Rs.6820.5125 lakh towards implementation of the project proposals of the Department of Agriculture under National Agriculture Development Programme 2016-17.

- 2. Subsequently, in the Government order 4<sup>th</sup> read above, the Government have also accorded administrative sanction for a sum of Rs.427.00 lakh and financial sanction for a sum of Rs.213.50 lakh towards implementation of the project proposal of the Department of Agriculture under National Agriculture Development Programme 2016-17.
- 3. Further, in the Government order 5<sup>th</sup> read above, orders have also been issued for a sum Rs.5310.00 lakh for implementation of "Samba Special Package 2016", assistance in Cauvery Delta Districts under National Agriculture Development Programme 2016-17 in respect of the Department of Agriculture.

- 4. In the letter 6<sup>th</sup> read above, the Government of India have released additional fund of Rs.50.00 crore as its 60% share under National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana 2016 17 for completion of ongoing projects approved by the State Level Sanctioning Committee of the State in its meeting held on 19.02.2016. The corresponding 40% State share is Rs.33.33 crore.
- 5. In the letter 7<sup>th</sup> read above, the Director of Agriculture, has sent the project proposal along with details of compliance to the State Level Sanctioning Committee resolution for the following projects to the tune of Rs.7284.40 lakh and proposed the same as 2<sup>nd</sup> release under National Agriculture Development Programme 2016-17 to the Government for issuing of orders. He has also stated that an amount of Rs.600.908 lakh is required for the component "Incentive for production of less than 10 years old certified paddy seeds" in P.P No.14.1. Due to the paucity of funds this year, only a sum of Rs.93.949 lakh has been proposed for the said component as 2<sup>nd</sup> release. To meet out the deficit of Rs.506.959 lakh, the Director of Agriculture has requested that the above amount shall be initially met from TANSEDA funds and subsequently reimbursed to TANSEDA after getting the approval of SLSC in the next year programme.

- 7. The Director of Agriculture is permitted, to meet the required fund for the component "Incentive for production of less than 10 years old certified paddy seeds" under PP. No.14.1 for an amount of Rs.506.959 lakh initially from TANSEDA and subsequently reimburse the said amount to TANSEDA after getting the approval of SLSC in the next year programme.
- 8. The Director of Agriculture is authorized to draw and disburse an amount of Rs.10.925 lakh to SIMA CDRA Coimbatore through Joint Directors of Agriculture, Coimbatore and the balance amount to District Joint Directors of Agriculture for the project 'Increasing Cotton Production and Productivity'.
- 9. The concerned District Joint Directors of Agriculture / Assistant Director of Agriculture are authorized to draw the amount allocated for conducting awareness

campaign in advance and incur expenditure for the project 'pulses improvement programme'.

- 10. The expenditure sanctioned in para.6 above shall be debited to the Heads of Account and component wise details of the projects annexed to this order.
- 11. Necessary additional funds will be provided in Final Modified Appropriation 2016-17 under the relevant heads of account. Pending provision of such funds the Director of Agriculture is permitted to draw and disburse the amount sanctioned in para. 6 above. However, the expenditure shall be brought to the notice of Legislature by specific inclusion in the Supplementary Estimate 2016-17. The Director of Agriculture is also requested to include this expenditure while sending the proposal for Final Modified Appropriation 2016-17 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimate 2016-17 to Government in Finance (Agri/BG.I) Department at the appropriate time without fail.
- 12. The funds available under existing Centrally Sponsored / Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above projects. The projects should follow centrally prescribed cost norms and approved pattern of assistance. The Director of Agriculture should take due care to ensure that there is no duplication of subsidy.
- 13. The Director of Agriculture should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the schemes.
- 14. The Director of Agriculture shall observe the comments / suggestions of State Level Sanctioning Committee while implementing the projects.
- 15. The Director of Agriculture is directed to follow the respective operational guidelines while implementing the schemes.
- 16. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the Head of Departments' to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to, by the implementing departments.
- 17. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the prescribed format by 10<sup>th</sup> of the subsequent month under intimation to this Government without fail.
- 18. This order issues with the concurrence of Finance Department vide its U.O.No. 8491/Agri/2017, dated: 02.03.2017 with Additional Sanction Ledger No. 2228 (Two Thousand Two Hundred and Twenty Eight)
