ORDER:

In the D.O. letter first read above, the Government of India have stated that in view of the recommendation of the 14th Finance Commission due to increased devolution to the States from 32 to 42 percent, the Government of India is considering to change the funding pattern of Centrally Sponsored Scheme of Mission on Integrated Development of Horticulture 50:50 (Centre : State) with the condition that the existing objectives and coverage targets of the Mission on Integrated Development of Horticulture/Micro irrigation (National Mission on Micro Irrigation/On Farm Water Management) are achieved even with reduced Central allocation as above. The proposed funding pattern will be in force for the remaining period of 12th Plan or till such time the NITI Aayog restructures the existing Centrally Sponsored Scheme in a comprehensive manner whichever is earlier.

2. In the letter second read above, the Government of India have approved Annual Action Plan and given administrative approval for Rs.72.75 crore to implement of Micro Irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) for the year 2015-2016.

3) In the Government Order fifth read above, Government have sanctioned and released a sum of Rs.6998.55 lakh which includes Government of India share amount of Rs.2656.83 lakh and matching State share of Rs.4341.7214 lakh as per the year 2014-15 subsidy pattern, for smooth and successful implementation of Micro Irrigation Scheme during 2015-16 under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) in Tamil Nadu as first phase. Further, it has been ordered that the additional share amount of Tamil Nadu as per the Pradhan Mantri Krishi Sinchayee Yojana will be sanctioned later. The Director of Horticulture & Plantation Crops/Managing Director, Tamil Nadu Horticulture Development Agency is directed to follow the existing guidelines while implementing the scheme of Pradhan Mantri Krishi Sinchayee Yojana during 2015-16 as per the cost norms specified in the Operational Guidelines of National Mission for sustainable Agriculture (NMSA) 2014-15 issued by Government of India.

4) In the letter fourth read above, Government of India have stated that the competent authority has revised the funding pattern of various schemes including Centrally Sponsored Scheme on Micro Irrigation under Pradhan Mantri Krishi Sinchayee Yojana 2015-16. Accordingly, the funding pattern shall now be 60:40 between the Central Government and State Government as detailed below:-

Further, it is clarified that 5% of total Release of Central Government Share will be earmarked for meeting administrative and other contingent expenses for implementation of the Mission and all expenditure on training programmes to be met out of Central Government Share.

5) In the letter third read above, the Government of India have released an amount of Rs.980.6700 lakh (Rs.764.920 for General Category, Rs.205.940 for SCSP Category and Rs.9.810 lakh for TSP Category) during 2015-16 as balance of first installment for implement of the Micro Irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana in Tamil Nadu.

6) In the letter sixth read above, the Director of Horticulture & Plantation Crops/Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to release the balance amount of first installment of

Rs.3298.9168 lakh (Government of India share of Rs.980.6700 lakh + State share of Rs.621.0910 lakh + Additional share amount of Rs.1697.1558 lakh) to implement the Micro Irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana (60:40 sharing pattern) during 2015-2016. as per the cost norms specified in the operation guidelines in National Mission on Sustainable Agriculture 2014-15 issued by Government of India.

7) The Government, after careful examination, accept the proposal of the Director of Horticulture and Plantation Crops/Managing Director, Tamil Nadu Horticulture Development Agency and accordingly sanction a sum of Rs.3298.9168 lakh (Rupees Thirty two crore ninety eight lakh ninety one thousand six hundred and eighty only) which includes Government of India share Rs.980.6700 lakh, State share Rs.621.0910 lakh and additional share of Rs.1697.1550 lakh, for General Category a sum of Rs.2573.1551 lakh, for SCSP Category a sum of Rs.692.7725 lakh and for TSP category a sum of Rs.32.9892 lakh towards the smooth and successful implementation of Micro Irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana during 2015-2016 in Tamil Nadu.

8) The expenditure sanctioned in para-7 above shall be debited to the following head of account:-
