ORDER:

In the Government Order first read above, the administrative approval has been accorded to Tamil Nadu Agricultural University, Coimbatore for the establishment of a new Horticultural College and Research Institute for Women at Navalur Kuttappattu, Tiruchirappalli District at an estimated cost of Rs.40.00 Crore spread over for four years.

2. In the Government Orders second, third and fourth read above, a total amount of Rs.25.90 crore has been sanctioned for the construction of buildings, student amenities and recurring contingencies etc.

3. In the letter fifth read above, the Registrar, Tamil Nadu Agricultural University has requested to sanction Rs.5.10 crore towards civil costs and operational costs for the new Horticulture College and Research Institute for women at Navalur Kuttappattu, Tiruchirappalli District.

4. The Government after careful consideration, accept the proposal of the Registrar, Tamil Nadu Agricultural University and accordingly accord sanction for a sum of Rs.5,10,00,000/- (Rupees five crore and ten lakh only) towards civil costs and operational costs for the new Horticulture College and Research Institute for women at Navalur Kuttappattu, Tiruchirappalli District.

5. The expenditure sanctioned in para 4 above, shall be debited to the following Head of Account:-

2415 - Agricultural Research and Education -01- Crop Husbandry - 120- Assistance to other Institutions - Schemes in the Twelfth Five year plan - II State Plan - JA - Grants to Tamil Nadu Agricultural University 09. Grants-in-Aid. -02. Grants for Creation of Capital Assets.

6. The expenditure sanctioned in para 4 above constitute an item of "New Instrument of Service". The approval of the legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the contingency fund. The Director of Agriculture is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency fund to Finance (BG-I) Department directly in Form - A appended to the Tamil Nadu Contingency Fund Rules - 1963 along with a copy of this order. Orders for sanction of advance from the Contingency Fund will be issued from Finance (BG-I) Department. He is also requested to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2015-2016 to Finance (Agri) Department at an appropriate time without fail.

7. The Registrar, Tamil Nadu Agricultural University is directed to follow the existing Financial Procedures/ Government Orders while incurring the expenditure sanctioned in para 4 above. He is also directed to release the amount to Public Works Department in phased manner based on the progress made in the work and with approval of Board of Management of Tamil Nadu Agricultural University.

8. This order issues with the concurrence of Finance Department vide its U.O. No. 8575/Agri/16, dated 10.12.2016 and Additional Sanction Ledger no.2302 (Two Thousand Three Hundred and Two).
