ORDER:

In the Government Order first read above, the Tamil Nadu Admission in Agricultural Institutions Rules, 2007 were framed for admission in Agricultural Professional courses in the Tamil Nadu Agricultural University.

2. In the Government Order second read above, certain amendments were made revising the eligibility criteria for Agricultural Science courses and Agricultural Engineering courses.

3. In the letter third read above, the Registrar, Tamil Nadu Agricultural University has stated that a four year degree programme in B.Sc.,(Sericulture) was started during the academic year 2011-2012 based on the economic and employment opportunities available for sericulture in Tamil Nadu. B.Sc., (Sericulture) was considered as professional degree by the 171st Board of Management of Tamil Nadu Agricultural University. Based on the directions of the Board of Management of Tamil Nadu Agricultural University, the Registrar, Tamil Nadu Agricultural University has sent a proposal to notify and declare B.Sc., (Sericulture) as professional Educational Course and also requested the Government to issue corresponding amendments to the Tamil Nadu Admission in the Agricultural Institutions Rules, 2007.

4. Accordingly, in the Government Order fourth read above, B.Sc., (Sericulture) is notified as Professional Educational Course.

5. In pursuance of the above, the Government have decided to amend the Tamil Nadu Admission in Agricultural Institutions Rules, 2007, suitably. Accordingly, the following Notification will be published in the Tamil Nadu Government Gazette.

NOTIFICATION

In exercise of the powers conferred by sub-section (1) of Section 10 of the Tamil Nadu Admission in Professional Educational Institutions Act, 2006 (Tamil Nadu Act 3 of 2007), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Admission in Agricultural Institutions Rules, 2007.

AMENDMENTS

In the said Rules, in rule 4,-

- (i) in clause (i), under the heading "Academic stream", under the sub-heading "I. Agricultural Science Courses", after the serial number (9) and the entry relating thereto, the following serial number and the entry shall, respectively be inserted, namely:-

"(10) "B.Sc., (Sericulture)";

- (ii) in clause (ii),-(a) in sub-clause (a), for the expression "and Bachelor of Science in Home Science", the following expression shall be substituted, namely :-

**"Bachelor of Science in Home Science and
Bachelor of Science in Sericulture";**

- (b) in sub-clause (c), in the TABLE, in column (1), after the expression "(4) Bachelor of Science in Home Science", the following expression shall be inserted, namely:-

"(5) Bachelor of Science in Sericulture".
