During the 12th State Level Sanctioning Committee meeting of National Agriculture Development Programme held on 14.11.2014 under the chairmanship of Chief Secretary to Government, the following project proposals of Department of Agriculture, among others, were approved for 2014-15:-

- 2. On 07.08.2014, under Rule 110 of the Tamil Nadu Legislative Assembly, among others, Hon'ble Chief Minister has announced that 7 New Liquid Bio Fertilizer Laboratories will be established to reduce the chemical fertilizers requirement. In this connection, the project "Strengthening of 10 Bio-fertilizer production units for the production of Liquid Bio-fertilizers and upgradation of 15 Bio-fertilizer Production Units for the Production of New Bio-fertilizers" approved in the 11th SLSC was modified as Establishment of Seven New Bio-fertilizer Production Units for the Production of Liquid Bio-fertilizers. The above said project was approved in the 12th State Level Sanctioning Committee meeting under National Agriculture Development Programme during the year 2014-15.
- 3. The Government of India have allocated Rs.279.95 crore under normal RKVY to the State of Tamil Nadu for the year 2014-15 and Rs.19.00 crore under sub-scheme.
- 4. Based on the comments of 12th State Level Sanctioning Committee and fund availability, the Director of Agriculture has sent the following proposals restricting the total project cost for some of the projects to Government for issue of orders:-

- 5. The Government, after careful examination, approve the above detailed project proposals of Director of Agriculture at a cost of Rs.376.08 lakh and accordingly sanction an amount of Rs. 376.08 lakh (Rupees Three crore seventy six lakh and eight thousand only) under National Agriculture Development programme / Rashtriya Krishi Vikas Yojana for 2014-15 for the above purpose to the implementing agency i.e. Director of Agriculture, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted.
- 6. The project Establishment of Seven New Bio-fertilizer Production Units for the Production of Liquid Bio-fertilizers shall be implemented at a total cost of Rs.893.00 lakh over a period of 2 years. Out of this, Rs.10.00 lakh is sanctioned for taking up the preliminary work during 2014-15. The balance amount of Rs.883.00 lakh will be allocated during 2015-16 under National Agriculture Development Programme. The New Bio-fertilizer Production Units for the Production of Liquid Bio-fertilizers shall be established in 7 districts viz., Dindigul, Vellore, Ariyalur, Villupuram, Madurai, Thiruvallur and Sivaganga.

- 7. The Joint Directors of Agriculture, Erode and Madurai is authorized to draw and disburse the amount earmarked for training under Diploma in Agricultural Extension Services for Input Dealers (DAESI) Course to the NGOs concerned.
- 8. The Director of Agriculture is authorized to draw and disburse an amount of Rs.99.980 lakh to the Chief Engineer, Public Works Department for Construction of First floor in SAMETI New Hostel, Kudumiyanmalai, Tamil Nadu.
- 9. Necessary additional funds will be provided in Final Modified Appropriation 2014-15 to meet the expenditure sanctioned in para 5 above. Pending provision of such funds in Final Modified Appropriation 2014-15, the Director of Agriculture is permitted to draw the amount sanctioned in para 5 above by relaxing quarterly restriction funds. However, this should be brought to the notice of legislature by specific inclusion in the Supplementary Estimates 2014-15. The Director of Agriculture is requested to include this expenditure sanctioned above, while sending the Budget Proposal for Final Modified Appropriation 2014-15 and also to send necessary Explanatory Notes for including the above expenditure in the Supplementary Estimates 2014-15 to Finance (BG-I / Agri) Department without fail.
- 10. The funds available under existing Centrally Sponsored Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above project. The project should follow centrally prescribed cost norms and approved pattern of assistance. The Department of Agriculture should take due care to ensure that there is no duplication of subsidy.
- 11. The Director of Agriculture should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the scheme.
- 12. The Director of Agriculture to follow the operational guidelines of National Agriculture Development Programme while implementing the above scheme.
- 13. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the HOD's concerned to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.
- 14. The Executive Director, Tamil Nadu Watershed Development Agency to send the monthly progress report to Government of India, in the prescribed format by 10th of the subsequent month under intimation to this Government without fail.
- 15. This order issues with the concurrence of Finance Department vide its U.O.No.72093/Agri/2014, dated: 13.01.2015 and Additional Sanction Ledger No. 2157 (Two Thousand One Hundred and Fifty Seven).
