ORDER:

In the Government order first read above, orders were issued according administrative approval for an outlay of Rs.100.670 lakh (Government of India Share Rs.60.402 lakh and State Share Rs.40.268 lakh) for implementation of NFSM-Commercial Crops (Cotton and Sugarcane) during 2016-17. - 4. The Government after careful examination of the proposal of Director of Agriculture, accord sanction for a sum of Rs.43.567 lakh (Rupees Forty three lakh fifty six thousand and seven hundred only) (GOI Share Rs.26.14 lakh and State Share Rs.17.427 lakh) as second installment for implementation of National Food Security Mission- Commercial Crops (cotton & sugarcane) on 60:40 sharing basis between Centre and State during 2016-17 as detailed in the annexure to this order.
- 5. The expenditure sanctioned in para 4 above shall be debited to the following head of account.

- 6. The Director of Agriculture is authorized to draw and deposit the Category wise / Crop wise sanctioned amount into the NFSM Bank Account maintained at Tamil Nadu Watershed Development Agency for implementation of National Food Security Mission programmes during 2016-17.
- 7.The Director of Agriculture is permitted to sanction Rs.21.25 lakh to "The Comptroller, Tamil Nadu Agricultural University for organizing Demonstration on Intercropping and Single bud chip technology with Sugarcane, for Breeder Seed Production, for Strengthening/establishment of Bio agent and tissue culture laboratory and to organize State Level training by Sugarcane Research Station, Cuddalore.
- 8. The Director of Agriculture is directed to strictly follow the revised guidelines of National Food Security Mission- Commercial Crops communicated by Government of India while implementing the scheme. He is also requested to take action to get the balance amount if any, from Government of India for the implementation of the scheme.
- 9. The Director of Agriculture is also requested to ensure that the statutory allocation under Special Component Plan (SCP) and Tribal Sub Plan (TSP) are made accordingly and also 30% of budgetary allocation is earmarked for women beneficiaries/farmers.
- 10. The Director of Agriculture is further requested to submit the monthly progress report incorporating target beneficiary-wise information by 15th of the following month regularly along with Annual Progress Report and Utilization Certificate in the prescribed format GFR-19(A) at the end of the year, to the Government of Tamil Nadu and Government of India.
- 11. This order issues with the concurrence of Finance Department vide its U.O. No.14002/Fin(Agri)/2017, Dated: 20.03.2017.
