ORDER

In the Government order first read above, administrative approval was accorded for the implementation of the National Food Security Mission during 2016-17 at an outlay of Rs.8368.00 lakh (Government of India share Rs.5020.800 lakh and State share Rs.3347.200 lakh) and also sanctioned a sum of Rs.4184.00 lakh (Government of India share Rs.2510.400 lakh and State share Rs.1673.00 lakh) towards the first installment with sharing pattern 60:40 by Centre and State.

2. The Government of India in their letters second read above have released 2nd installment of fund for NFSM - Rice, NFSM - Pulses and NFSM - Coarse Cereals for the year 2016-17 as detailed below:

In the reference third read above, the Director of Agriculture has sent proposals to the Government for sanction of Rs.2541.066 lakh (Government of India share Rs.1524.640 lakh and State Share Rs.1016.426 lakh) as 2nd Installment for the implementation of National Food Security Mission during 2016-17. The Director of Agriculture has also furnished the category and crop wise matching State share to be released on 60:40 sharing by centre and state as detailed below:-

4. The Director of Agriculture has further informed that under National Food Security Mission Pulses, Government of India's release of funds under SC category & ST is 29 % & 2 % respectively as against the normal sanction of 19 % & 1 % respectively and hence the Department considering the SC/ST population in the State and general flow of funds to SC/ST Category (19 % & 1 % for SC & ST respectively) have proposed financial sanction by reducing the matching State Share under SCP category & ST under National Food Security Mission Pulses alone. Thus, considering the Government of India release of funds, the Department has proposed sanction of funds for second installment along with State share on 60: 40 sharing by Centre and State under General, SCP category & ST as detailed as below:-

- 5. The Director of Agriculture has therefore requested the Government to accord financial sanction of Rs.2541.066 lakh (Government of India Share Rs.1524.640 lakh and State share Rs.1016.426 lakh) as second installment for implementation of NFSM Rice, NFSM Pulses and NFSM Coarse Cereals during 2016-17.
- 6. The Government, after careful examination of the proposal of the Director of Agriculture accord sanction for an amount of Rs.1839.167 lakh (Rupees Eighteen crore thirty nine lakh sixteen thousand and seven hundred only) (Government of India Share Rs.1524.640 lakh and State share Rs.314.527 lakh) as second installment for implementation of National Food Security Mission as detailed in the annexures I III to this order during 2016-2017. - 8. The Director of Agriculture is authorized to draw and deposit the Category wise / Crop wise sanctioned amount into the National Food Security Mission Bank Account maintained at Tamil Nadu Watershed Development Agency for implementation of National Food Security Mission programmes during 2016-17.
- 9. The District Joint Directors of Agriculture are authorized to draw the required amount to conduct Cropping Based Training as per the target under NFSM Rice & Pulses.
- 10. The Director of Agriculture is directed to strictly follow the revised guidelines of National Food Security Mission communicated by Government of India while implementing the scheme. He is also requested to take action to get the balance amount from Government of India if any for the implementation of the scheme.
- 11. The Director of Agriculture is also requested to ensure that the statutory allocation under Special Component Plan (SCP) and Tribal Sub Plan (TSP) are made accordingly and also 30% of budgetary allocation is earmarked for women beneficiaries/farmers.
- 12. The Director of Agriculture is further requested to submit the monthly progress report incorporating target beneficiary-wise information by 15th of the following month regularly along with Annual Progress Report and Utilization Certificate in the prescribed format GFR–19(A) at the end of the year, to the Government of Tamil Nadu and Government of India.
