## ORDER:-

In the Government Order first read above, the Government have accorded administrative and financial sanction for a sum of Rs.591.67 lakh (Government of India share – Rs.355.00 lakh + State Share – Rs.236.67 lakh) and released a sum of Rs.400.30 lakh for implementation of National e-Governance Plan for Agriculture (NeGP-A) during the year 2019-2020. In the Government Order, it has been informed that the balance amount of Rs.191.37 lakh will be released in the Financial year 2020-2021as detailed below:-

- 2) The Director of Agriculture has now informed that the released amount of Rs.400.30 lakh was withdrawn and deposited the same in Ne-GP-A account kept at Tamil Nadu Watershed Development Agency. However, the earmarked activities can be carried out once the receipt of remaining funds of Rs.191.37 lakh as per the financial sanction.
- 3) The Government after careful examination of the proposal of the Director of Agriculture, release the balance amount of Rs.191.37 lakh (Rupees One crore ninety one lakh thirty seven thousand only) for implementation of National e-Governance Plan for Agriculture (NeGP-A) of the year 2019-2020 in the financial year 2020-2021.

5) Necessary additional funds of Rs.28.42 lakh will be provided in Revised Estimate / Final Modified Appropriation 2020-2021. Pending provision of such funds, the Director of Agriculture is authorized to draw and disburse the amount sanctioned in para 3 above. However, the expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2020-2021. The Director of Agriculture is directed to include this expenditure while sending the Budget Proposal for Revised Estimate / Final Modified Appropriation 2020-2021 and also to send necessary draft explanatory notes for including the above expenditure in

the Supplementary Estimates 2020-2021 to Government in Finance (BG-1/Agri) Department at the appropriate time without fail.

- 6) The Government permit the Director of Agriculture to withdraw the entire amount sanctioned in para 3 above and deposit the same in the National e-Governance Plan for Agriculture Bank account maintained by the Tamil Nadu Watershed Development Agency (TAWDEVA), Chennai-32.
- 7) The Director of Agriculture is instructed to follow the guidelines specified in the Government Order first read above.
- 8) This order issues with the concurrence of Finance Department vide its U.O. No.15011/Fin(Agri)/2020, dated 7.5.2020 and Additional Sanction Ledger No.0046 (Forty Six).
