ORDER:

In the Government Order first read above, orders were issued for implementation of National Agricultural Insurance Scheme during 2015-2016 and an amount of Rs.30.0062 crore was sanctioned towards payment of 50% premium subsidy for loanee and non-loanee farmers including tenant farmers for agricultural crops and expenditure towards advertisement and contingencies.

2. In the Government Order second read above, sanction was accorded for a sum of Rs.22.346 crore towards the settlement of pending State share of premium subsidy and bank charges for Kharif, 2015 and Paddy II (S/T/P) 2015-2016 season under National Agricultural Insurance Scheme to Agriculture Insurance Company of India Limited during the year 2016-2017.

3. In the Government Order third read above, sanction was accorded for a sum of Rs.10.4106 crore towards the settlement of State share of premium subsidy and bank charges for Rabi, 2015-2016 under National Agricultural Insurance Scheme to Agriculture Insurance Company of India Limited during the year 2016-2017.

4. In the Government Order fourth read above, orders were issued sanctioning a sum of Rs.168,65,95,729/- towards the settlement of State share of compensation claims for Paddy II (S/T/P) Rabi season under National Agricultural Insurance Scheme for the year 2015-2016.

5. In the Government Order fifth read above, orders were issued sanctioning a sum of Rs.9,20,69,009/- as State share towards the payment of compensation claims for Other Rabi crops of 2015 - 2016 season under National Agricultural Insurance Scheme.

6. The Director of Agriculture in his letter sixth read above has informed that Agriculture Insurance Company of India Limited has requested to give consent for providing a sum of Rs.25,71,389/- as State share of compensation claims that have arisen due to incorrect indication of firka in the declaration of 366 non-loanee farmers (wrongly grouped under Kattumannarkoil, Kumaratchi, Vridhachalam (North) firkas instead of Srimushanam, Kumaratchi, Vridhachalam (South) firkas) for Paddy II (S/T/P) Rabi, 2015-16 under National Agricultural Insurance Scheme furnished by the District Central Cooperative Bank, Cuddalore to Agriculture Insurance Company of India Limited, Chennai.

7. The Director of Agriculture in his letter seventh read above has further informed that this subject will be placed before the forthcoming State Level Coordination Committee on Crop Insurance meeting to be held for Kharif, 2018 for ratification of getting the consent of the State Government in advance.

8. The Director of Agriculture has, therefore, requested the Government to give consent to provide the State share of Rs.25,71,389/- towards the payment of compensation claims to 366 farmers of Cuddalore District for Paddy II (S/T/P) Rabi, 2015-16 under National Agricultural Insurance Scheme subject to ratification in the forthcoming State Level Coordination Committee on Crop Insurance meeting to be held for Kharif, 2018.

9. The Government, after careful examination of the above proposal of the Director of Agriculture hereby accord consent to provide the State share of Rs.25,71,389/- (Rupees Twenty Five Lakh Seventy One Thousand Three Hundred and Eighty Nine only) towards the payment of compensation claims to 366 farmers of Cuddalore District for Paddy II (S/T/P) Rabi, 2015-2016 under National Agricultural Insurance Scheme. Further, the Director of Agriculture is directed to place the above subject in the forthcoming State Level Coordination Committee on Crop Insurance meeting for Kharif, 2018 for its ratification.
