ORDER:

The Government of India in their letter first read above, had approved the Annual Action Plan 2016-17 of the National Horticulture Mission (NHM) under the Mission for Integrated Development of Horticulture (MIDH) at an outlay of Rs.91.72 crore in the funding pattern of 60:40 between the Centre and State.

2. In G.O. second read above the Government had sanctioned and released the first instalment Rs.45,83,33,300/- including the State matching share Rs.18,33,33,300/- to implement the scheme during the current year 2016-17. Subsequently, in G.O. third read above, the Government had sanctioned and released a sum of Rs.7,72,50,000/- as second instalment which includes Government of India share of Rs.4,63,50,000/- and State Matching Share of Rs.3,09,00,000/- towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture during 2016-17 in Tamil Nadu.

3. In letter fifth read above, the Managing Director, Tamil Nadu Horticulture Development Agency has stated that, the Government of India has released a sum of Rs.1500.00 lakh towards third instalment for implementation of scheme under National Horticulture Mission. The details of funds released by the Government of India and the corresponding State Matching Share required are as below:-

Hence, the Director of Horticulture and Plantation Crops / Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to sanction and release an amount of Rs. 2500.00 lakh (Rupees Twenty five crore only) which includes Government of India share of Rs.1500.00 lakh, and the State Matching Share of Rs.1000.00 lakh, as third instalment for the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture Scheme in Tamil Nadu during 2016-17.

- 4. The Government after careful examination, accept the proposal of the Director of Horticulture & Plantation Crops/Managing Director, Tamil Nadu Horticulture Development Agency and accordingly, sanction and release a sum of Rs. 2391.87 lakh (Rupees Twenty three crore ninety one lakh and eighty seven thousand only) which includes Government of India share of Rs. 1500.00 lakh and State matching share of Rs.891.87 lakh as third instalment towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture Scheme in Tamil Nadu during 2016-17. The balance amount shall be released in the next financial year 2017-18. The Director of Horticulture and Plantation Crops is directed to send necessary proposal after 1.4.2017 to release the balance amount.
