ORDER:

In the Government order first read above, orders have been issued according administrative approval for the implementation of Pradhan Mantri Fasal Bima Yojana (PMFBY) during 2018-2019 in Tamil Nadu at a cost of Rs.631.60 crore in all the districts of Tamil Nadu (except Chennai).

2. The 41st State Level Coordination Committee on Crop Insurance meeting for notifying Rabi Crops during 2018-2019 under Pradhan Mantri Fasal Bima Yojana (PMFBY) was held on 11.10.2018 and the Committee accepted to notify the Crops, Districts, Firkas and Revenue Villages for Agricultural and Horticultural Crops and for notification of Insurance Units and publication in the State Gazette.

3. In his letter third read above, the Director of Agriculture has stated that the Sowing Season for Rabi Crops in Tamil Nadu commences in the month of October and prolongs upto March. Hence, the Crops / Insurance units have to be notified under Pradhan Mantri Fasal Bima Yojana during Rabi 2018-2019. Accordingly, the 41st State Level Coordination Committee meeting was conducted on 11.10.2018 to notify Rabi

Agricultural and Horticultural Crops during 2018-2019 under Pradhan Mantri Fasal Bima Yojana and the Committee has finalized the insurance units and approved premium rates and accepted for notification. In accordance to this, he has sent a proposal for notification of Rabi Crops during 2018-2019 and requested the Government to issue orders and also publish the notification in the Government Gazette.

4. The Government, after careful examination of the proposal of the Director of Agriculture accept the same and accordingly hereby notify the Crops, Districts, Firkas, Revenue Villages, insurance units and approved premium rates for Agricultural and Horticultural Crops for the effective implementation of the Pradhan Mantri Fasal Bima Yojana during Rabi 2018-2019 season as shown in the Annexures I, II, III and IV to this order.

5. The claims under the Pradhan Mantri Fasal Bima Yojana Scheme shall be settled on the basis of yield data furnished by the Department of Economics and Statistics as per prescribed cut-off dates for the notified crops / districts / firkas / revenue villages for the effective implementation of Pradhan Mantri Fasal Bima Yojana scheme during Rabi 2018-2019 season and not on the basis of the Annavari Certificate / Gazette notification declaring the area as Drought / Flood / Cyclone affected etc., by the District Collectors.

NOTIFICATION FOR RABI CROPS DURING 2018 -2019

ANNEXURE I

[G.O.(Rt).No.319, Agriculture (AP2) Department, dated 1.11.2018.]

Pradhan Mantri Fasal Bima Yojana (PMFBY) will be implemented in all the districts of Tamil Nadu (except Chennai) with the State Government subsidy during 2018-2019 for Rabi Crops.

I. OBJECTIVES OF PRADHAN MANTRI FASAL BIMA YOJANA:

Pradhan Mantri Fasal Bima Yojana aims at supporting sustainable production in agriculture by way of

- a) Providing financial support to farmers suffering crop loss/damage arising out of unforeseen events.
- b) Stabilizing the income of farmers to ensure their continuance in farming.
- c) Encouraging farmers to adopt innovative and modern agriculture practices.
- d) Ensuring flow of credit to the agriculture sector, which will, contribute to food security, crop diversification and enhancing growth and competitiveness of agriculture sector besides protecting farmers from production risks.

II. COVERAGE OF FARMERS:

All farmers including share croppers and tenant farmers growing the notified crops in the notified areas are eligible for coverage.

- Compulsory for Loanee farmers.
- Optional for Non - Loanee farmers.

IV. COVERAGE OF RISKS AND EXCLUSIONS:

The following stages of the crop and Risks leading to crop loss are covered under the scheme:

1. **PREVENTED SOWING/ PLANTING RISK** – If Insured area is prevented from sowing / planting due to deficit rainfall or adverse seasonal conditions and non release of irrigation water on scheduled date of opening of dam for irrigation in its command areas. Prevented sowing will be applicable only for major crops notified at Revenue Village level.
2. **STANDING CROP (SOWING TO HARVESTING)** - Comprehensive risk insurance is provided to cover yield losses due to non - preventable risks viz. Drought, dry spells, flood, inundation, pests and diseases, landslides, natural fire and lightening, storm, hailstorm, cyclone, typhoon, tempest, hurricane and tornado.
3. **POST-HARVEST LOSSES** - Coverage against specific perils of cyclone, cyclonic rains and unseasonal rains is available only upto a maximum period of two weeks from harvesting, for those crops which are allowed to dry in cut and spread condition in the field after harvesting.
4. **LOCALIZED CALAMITIES** - Loss/damage resulting due to occurrence of identified localized risks viz., hailstorm, landslide and inundation affecting isolated farms in the notified area.

The District Level Monitoring Committee under the Chairmanship of District Collector is authorized to fix the seasonality discipline for prevented sowing / failed sowing and Post harvest losses at farm level and mid-season adversity for on-account payment (vide G.O.Ms.No.293, Agriculture (AP6) Department, dated 12.9.2016) as done during 2016-2017.

- The Insurance Companies shall reconcile with the Department of Economics & Statistics for any discrepancies noted in the hierarchy of the notified units at any stage of implementation of the scheme during enrolment, implementation / uploading on Government portal while processing the compensation.

VI. PREMIUM RATE AND PREMIUM SUBSIDY:

FARMER'S PREMIUM:

Actuarial Premium Rate (APR) would be charged under Pradhan Mantri Fasal Bima Yojana by the Implementing Agency (IA). The rate of Insurance Charges for Rabi crops (All Food Grains (Cereals, Millets, Pulses) & Oilseeds) payable by the farmer is 1.5% of Sum Insured or Actuarial rate, whichever is less while it is 5% of Sum Insured or Actuarial rate, whichever is less for Annual Commercial / Annual Horticultural Crops.

The notified cluster-wise, district-wise Actuarial premium rate and the premium rate for farmers as approved in the tender agreement for crops notified during Rabi 2018 -2019 is annexed (**Annexure III**). As directed by the Committee, the premium rates quoted for Greengram & Groundnut for Coimbatore; Maize & Cotton for Cuddalore; Chillies of Ramanathapuram; Banana, Tapioca and Potato of Nilgiris; Banana, Onion & Chillies of Thoothukudi and Banana of Theni have also been included in the annexure and New India Assurance Company Limited shall adopt the stipulated farmers' share of premium (i.e.) 1.5% for Redgram in Dharmapuri, Pudukottai and Virudhunagar districts instead of 5% quoted in the tender and 3.97% instead of 3.77% for Banana in Dharmapuri district.

VII. SUM INSURED:

The Scale of Finance approved by the State Level Technical Committee for 2018-2019 shall be adopted as Sum Insured for the crops notified during 2018-2019 as per Para No.VII(1) of the Operational Guidelines of Pradhan Mantri Fasal Bima Yojana. The approved Sum Insured in terms of Rupees per hectare has been annexed (**Annexure IV**). The Sum Insured will be the same for both loanee and non-loanee farmers.
