### **ORDER:**

In the Government order first read above, among others, orders have been issued according administrative approval for the implementation of Pradhan Mantri Fasal Bima Yojana at a cost of Rs.522.70 crore in all the districts of Tamil Nadu except Chennai during 2017 - 2018.

2. In the Government Order second read above, the Government have issued orders for notification of scale of finance for the year 2017-2018 for all the crops (except sugarcane) as sum insured for the crops notified during 2017-2018 under Pradhan Mantri Fasal Bima Yojana .

3. In his letter fourth read above, the Director of Agriculture has stated that 39<sup>th</sup> State Level Coordination Committee on Crop Insurance meeting was held on 13.10.2017 for implementation of Pradhan Mantri Fasal Bima Yojana (PMFBY) in Tamil Nadu during Rabi 2017-2018 and the Committee has finalized the insurance units and approved premium rates and accepted for notification. In accordance to this, he has sent the notification proposal for implementation of Pradhan Mantri Fasal Bima

Yojana during Rabi 2017-2018 for approval and issue of Government Orders and notification. In his proposal he has stated that Pradhan Mantri Fasal Bima Yojana (PMFBY) will be implemented in all the districts of Tamil Nadu (except Chennai) with the State Government subsidy during 2017-2018 for Rabi Crops and furnished the details about objectives, coverage of farmers, coverage of risks and exclusions, sum insured, premium rate and premium subsidy, seasonality discipline / cut-off date, notification of districts, crops, blocks, firkas, revenue villages for Rabi - 2017-2018 under Pradhan Mantri Fasal Bima Yojana and requested the Government to issue orders and also to publish the notification in the Government Gazette.

4. The Government, after careful examination of the proposal of the Director of Agriculture accept the same and accordingly hereby notify the Crops, Districts, Firkas, Revenue Villages, insurance units, approved premium rates for Agriculture and Horticulture Crops and scale of finance for Agriculture and Horticulture Crops including Sugarcane for the effective implementation of the Pradhan Mantri Fasal Bima Yojana during Rabi 2017-2018 season as shown in the Annexures I, II and III to this order.

5. The claims under the Pradhan Mantri Fasal Bima Yojana Scheme shall be settled on the basis of yield data furnished by the Director, Department of Economics and Statistics as per prescribed cut-off dates for the notified crops / districts / firkas / revenue villages for the effective implementation of Pradhan Mantri Fasal Bima Yojana scheme for Rabi 2017-2018 season and not on the basis of the Annavari Certificate / Gazette notification declaring the area as Drought / Flood / Cyclone affected etc., by the District Collectors.

**ANNEXURE I**

**[G.O.(Rt).No.320 Agriculture (AP6) Department, dated 22.09.2017]**

Pradhan Mantri Fasal Bima Yojana (PMFBY) will be implemented in all the districts of Tamil Nadu (except Chennai) with the State Government subsidy during 2017-2018 for Rabi Crops.

**I. OBJECTIVES OF PRADHAN MANTRI FASAL BIMA YOJANA :**

Pradhan Mantri Fasal Bima Yojana aims at supporting sustainable production in agriculture by way of

- a) Providing financial support to farmers suffering crop loss/damage arising out of unforeseen events.
- b) Stabilizing the income of farmers to ensure their continuance in farming.
- c) Encouraging farmers to adopt innovative and modern agriculture practices.
- d) Ensuring flow of credit to the agriculture sector, which will, contribute to food security, crop diversification and enhancing growth and competitiveness of agriculture sector besides protecting farmers from production risks.

**II. COVERAGE OF FARMERS:**

All farmers including share croppers and tenant farmers growing the notified crops in the notified areas are eligible for coverage.

- Compulsory for Loanee farmers.
- Optional for Non - Loanee farmers.

#### **IV. COVERAGE OF RISKS AND EXCLUSIONS:**

The following stages of the crop and Risks leading to crop loss are covered under the scheme:

- 1. PREVENTED SOWING/ PLANTING RISK** – If Insured area is prevented from sowing / planting due to deficit rainfall or adverse seasonal conditions and non release of irrigation water on scheduled date of opening of dam for irrigation in its command areas.
- 2. STANDING CROP (SOWING TO HARVESTING)** - Comprehensive risk insurance is provided to cover yield losses due to non - preventable risks viz. Drought, dry spells, flood, inundation, pests and diseases, landslides, natural fire and lightening, storm, hailstorm, cyclone, typhoon, tempest, hurricane and tornado.
- 3. POST-HARVEST LOSSES** - Coverage against specific perils of cyclone, cyclonic rains and unseasonal rains is available only upto a maximum period of two weeks from harvesting, for those crops which are allowed to dry in cut and spread condition in the field after harvesting.
- 4. LOCALIZED CALAMITIES** - Loss/damage resulting due to occurrence of identified localized risks viz., hailstorm, landslide and inundation affecting isolated farms in the notified area.

In the 39<sup>th</sup> State Level Coordination Committee on Crop Insurance meeting conducted on 13.10.2017 for notification of Rabi crops during 2017-18, the Committee

has authorized the District Level Monitoring Committee under the Chairmanship of District Collector to fix the seasonality discipline for prevented sowing/failed sowing and Post harvest losses at farm level and mid-season adversity for on-account payment (vide G.O.Ms.No.293, Agriculture (AP6) Department, dated 12.9.2016) as done during 2016-2017.

#### VI. PREMIUM RATE AND PREMIUM SUBSIDY:

##### FARMER'S PREMIUM:

Actuarial Premium Rate (APR) would be charged under Pradhan Mantri Fasal Bima Yojana by the Implementing Agency (IA). The rate of Insurance Charges for Rabi crops (All Food Grains (Cereals, Millets, Pulses) & Oilseeds) payable by the farmer is 1.5% of Sum Insured or Actuarial rate, whichever is less while it is 5% of Sum Insured or Actuarial rate, whichever is less for Annual Commercial / Annual Horticultural Crops.


