Sub: Agriculture Department–Horticulture–Tamil Nadu Horticulture Development Agency- Implementation of Micro Irrigation Scheme under "Per Drop More Crop" component of Pradhan Mantri Krishi Sinchayee Yojana 2016-17 — Revision of Portable Sprinkler subsidy - Permission to provide 4kg/cm2 pipes instead of 3.2 kg/cm2 pipes and allowing the cost difference of Rs.3000/-per ha in Nilgiris District - Orders - Issued.

I am directed to invite your attention to the reference cited and to state that the Government permit to provide 4kg/cm2 pipes instead of 3.2 kg/cm2 pipes and allowing the cost difference of Rs.3000/- per ha in Nilgiris District towards Implementation of Micro Irrigation Scheme under "Per Drop More Crop" component of Pradhan Mantri Krishi Sinchayee Yojana 2016-17 and such additional cost should be met within the overall amount allocated/ sanctioned to Nilgiris district or by diversion of amount from some other districts. In any case no additional amount will be sanctioned by State Government for this purpose.
